Subj: INSTRUCTIONS FOR THE RESIDENTS OF FAMILY HOUSING

Ref: (a) Unified Facilities Criteria 4-711-01 Family Housing, 13 July 2006
(b) MCO P11000.22
(c) Housing Instruction Manual

1. Situation. In accordance with the references, the Commanding General is responsible for adequate family housing and quality living environments for service members and their families assigned to the Combat Center. Regulations and instructions are published; see reference (c), to promote community security and safety.

2. Cancellation. CCO P11101.12L.

3. Mission. To provide local instructions and policies to supplement regulations contained in references (a) and (b) for the residents of family housing at the Combat Center and Vista del Sol Housing, Twentynine Palms, California.

4. Execution

a. Commander's Intent and Concept of Operations

(1) Commander's Intent. To publish guidance and information that clarifies and amplifies the rules and responsibilities of residents living in family housing at the Combat Center and Vista del Sol Housing.

(2) Concept of Operations. The Assistant Chief of Staff G-4, Family Housing division is committed to assist with housing needs and strives to maintain family quarters in the best possible condition and within current policies of the Marine Corps and the Department of the Navy.

b. Subordinate Element Missions. Commanding Officers, Assistant Chiefs of Staff, and Special Staff Officers in Charge will ensure Marines and Sailors in their charge are familiar with and comply with the instructions in this Order and reference (c), which sets forth local instructions for residents of military family housing.


