Subj: TRANSIENT QUARTERS INSTRUCTION MANUAL

1. Situation. To provide information and instructions for the management, inspection, administration, and utilization of the transient quarters (TQ) aboard the Marine Air Ground Task Force Training Command, Marine Corps Air Ground Combat Center.

2. Cancellation. CCO 11012.8H.

3. Mission. To implement references (a) through (c), and establish local policies and procedures, reference (d), to be followed by the residents and personnel managing TQ aboard the Combat Center.

4. Execution

a. Commander's Intent and Concept of Operations

(1) Commander's Intent. To provide procedures for managing TQ, ensuring quarters are properly maintained, and ensuring residents follow established regulations while occupying quarters.

(2) Concept of Operations

(a) Reference (d) sets forth the basic regulations which govern the TQ aboard the Combat Center.

(b) The Director, Bachelor Billeting Division, is responsible to the Assistant Chief of Staff (AC/S) G-4, for providing proper management, inspection, maintenance, and utilization of the TQ.

b. Subordinate Element Missions

(1) Commanding Officers and Officers-in-Charge. Commanding Officers and Officers-in-Charge will ensure personnel whom reside in the TQ comply with this Order and the policies contained in the references.

(2) Assistant Chief of Staff G-4. The AC/S G-4 will ensure that reference (d) is reviewed annually, complies with higher level directives contained in the references, and is available for units to review and utilize.


