1. Situation. The Marine Air Ground Task Force Training Command, Marine Corps Air Ground Combat Center shall operate in an environmentally sound manner and comply with applicable environmental statutes and regulations.

2. Cancellation. CCO 5090.1E.

3. Mission. To implement references (a) through (k), and establish local policies and procedures in reference (l).

4. Execution

a. Commander's Intent and Concept of Operations

(1) Commander's Intent. The Combat Center is committed to applying sound environmental management practices to our command's resources and continually improving these practices to strengthen our training mission; therefore, Commanding Officers (CO), Assistant Chiefs of Staff (AC/S), Special Staff Officers, Officers In Charge (OIC), and contractors training and operating aboard the Combat Center shall comply with the provisions of this Order.

(2) Concept of Operations

(a) References (a) through (k) set forth the basic regulations which govern the management and protection of the Combat Center's environment and its natural and cultural resources.

(b) COs, AC/S, Special Staff Officers, OICs, and contractors training and operating aboard the Combat Center are responsible for supporting the AC/S G-4 in protecting the Combat Center's resources.

b. Subordinate Element Missions

(1) Commanding Officers, Assistant Chiefs of Staff, Special Staff Officers, Officers In Charge, and Contractors

(a) Ensure compliance with this Order, references (a) through (g), and the local policies contained in the reference (1).

(b) Ensure that violations and violators are promptly reported to the Natural Resources and Environmental Affairs division.

(c) Ensure that the requirements of the National Environmental Policy Act, as identified in reference (d), are completed on actions requiring environmental documentation.

(2) Assistant Chief of Staff G-3

(a) Ensure that all units training at the Combat Center receive a brief of this Order, and are familiar with its contents prior to utilizing training areas and ranges.

(b) Ensure compliance with the provisions outlined in subparagraph 4b(1) of this Order.

(3) Assistant Chief of Staff G-4

(a) Is responsible for establishing policies and standard operating procedures for the management and protection of the Combat Center's environment, including natural and cultural resources.

(b) Ensure that the environmental protection standard operating procedures are reviewed annually, complies with higher level directives contained in the references, and is available for units to utilize.


