In December 1998, Sergeant Kelly transferred to 1st Battalion 7th Marines where he assumed duties as the Embarkation NCO/Logistics Chief. Sergeant Kelly was part of numerous Unit Deployments to Okinawa Japan and was also forward deployed in support of Operation Iraqi Freedom.
