Prior to accepting government quarters, the following statements must be read and initialed indicating understanding that compliance is required per the reference. Failure to read reference (a) will not relieve you of responsibility should you violate its provisions _____

Occupancy of at least six (6) months duration will be required. _____

A thirty (30) day notice of intent to vacate will be required before moving out of quarters. Sixty (60) days notice is preferred. _____

Assignment to housing is not a valid reason for breaking a lease if I inform the assignment counselor that I have a lease I will maintain my position on the waiting list until my lease expires. _____

I understand and agree that I must report to IPAC within three days to inform them of the change in address and to review other entitlements that may or may not be authorized at this time. I am aware of the necessity to monitor my LES for appropriate changes in BAH entitlement. _____

The following provisions apply for pet ownership in housing. ____ *On Base Housing allows 2 pets, dogs and / or cats.

Pit Bulls, Rottweiler's and Wolf Hybrids or any mix thereof, and potentially dangerous animals are not permitted in family housing. _____

All dogs will be kept in fenced yards (where allowed). Pets may not stay on enclosed patios for an extended period of time. A fence permit approved by housing is required prior to installing a fence. _____

Wading pools: maximum size is 8' diameter by 2' deep, require adult supervision at all times, are to be utilized only in an enclosed porch or fenced yard and be emptied and stored daily. Jacuzzi's/hot tubs are not permitted in housing. Special request may be made for medical reasons and if approved, resident will be responsible for any additional electric equipment installation. _____

Trampoline must be enclosed and are only allowed in fenced yards which restrict usage by most of the general population in base housing. _____

Service members are advised if they voluntarily move out of quarters, they will not be eligible to reapply for six (6) months. _____

Every effort is made to communicate changes and notifications of events that will impact you as a resident. Your initials below indicate your understanding that you accept responsibility to be an informed resident by reading all newsletters,, awareness of speed calls, combat center news on the local radio station and cable channel 6, flyers, and housing web page updates. _____
