Subj: HOLIDAY LIBERTY PERIODS FOR CALENDAR YEAR 2026

1. Situation. In accordance with the references, this Combat Center Bulletin (CCBul) updates the schedule for Calendar Year 2026 holiday liberty periods observed by personnel assigned to Marine Air Ground Task Force Training Command (MAGTFTC), Marine Corps Air Ground Combat Center (MCAGCC).

2. Mission. MAGTFTC, MCAGCC Assistant Chiefs of Staff (ACs/S), Commanding Officers (COs), Officers-in-Charge (OICs), Division Directors (DivDirs), and Special Staff Officers (SSOs) will provide holiday liberty for their Marines and Sailors as established in this Bulletin.

3. Cancellation. CCBul 1050 Holiday Liberty Periods for Calendar Year 2025.

4. Execution

a. Commander's Intent and Concept of Operations

(1) Commander's Intent. To provide our Marines and Sailors with holiday liberty periods to ensure adequate travel time is allocated at the beginning and end of each holiday period.

(2) Concept of Operations. ACs/S, COs, OICs, DivDirs, and SSOs may adjust the holiday liberty periods as necessary to meet operational requirements.

b. Subordinate Element Missions

(1) MAGTFTC, MCAGCC ACs/S, COs, OICs, DivDirs, and SSOs

(a) Comply with the contents of this Bulletin.

(b) Ensure personnel are reminded to be safety conscious throughout the holiday liberty period, particularly when operating a motor vehicle.

(c) Ensure personnel have the telephone number of their respective Command Duty Officer prior to departing their assigned place of duty.

(d) Subordinate Commanders are authorized to establish liberty

periods in support of their own Marine Corps Ball; however, coordination with the Chief of Staff (C/S) must occur before formalizing any contracts. Ball dates and times should be submitted to the C/S no later than 90 days prior to the holiday liberty period.

(e) Authorization for 72 or 96 special liberty periods to include deviations from this CCBul.

1. Commanders are authorized to grant liberty periods up to 96 hours for individuals, work sections, or companies within the organization.

2. Approval of a 72 or 96 special liberty period for an entire unit resides with the Commanding General.

3. If a Commander needs to deviate from this CCBul for operational reasons, that Commander will inform the C/S via the G-1 Manpower, Adjutant's office no later than 60 days prior to the holiday liberty period.

(2) MCAGCC Tenant Commanders. Holiday liberty periods may be further established by your respective higher headquarters.

c. Coordinating Instructions

(2) Prior to granting leave or liberty, COs, ACs/S, OICs, DivDirs, and SSOs will ensure each section is capable of handling routine matters.

(3) Liberal leave policy will be in effect for civilian employees during these periods. Supervisors are encouraged to approve annual leave requests in other than essential positions.

(4) Resident units aboard the Combat Center may have different liberty periods during the year. Prior planning and coordination should be conducted accordingly.
