1. Situation. The references require the Installation Commander to publish an annual consolidated list of all restricted areas aboard a Marine Corps Base, including all tenant command restricted areas.

2. Mission. To publish a listing of all restricted areas, including all tenant command restricted areas, aboard Marine Air Ground Task Force Training Command, Marine Corps Air Ground Combat Center, which hereafter will be referred to as "Combat Center".

3. Execution

a. Commander's Intent and Concept of Operations

(1) Commander's Intent. To ensure the review, concurrence, and signature of the Consolidated List of Designated Restricted Areas, which will be designated as Controlled Unclassified Information (CUI).

(2) Concept of Operations. All commands, organizations, units, and activities will provide a list of all restricted areas to the Commanding General (CG), via the Provost Marshal's Office (PMO).

b. Subordinate Element Missions. All originating offices that have designated restricted areas will comply with the intent of the references and the content of this Bulletin.

c. Coordinating Instructions

(1) Commands, Organizations, and Units. All Commanding Officers (COs), Assistant Chiefs of Staff (ACs/S), Officers-in-Charge (OICs), and Special Staff Officers are required to read the policies and guidance for restricted areas within reference (a) and publish in writing, an annual list of all restricted areas under their jurisdiction and control.

DISTRIBUTION STATEMENT B: Distribution authorized only for MAGTFTC, MCAGCC Commanding Officers, Assistant Chiefs of Staff, Officers-In-Charge, and Special Staff Officers, less operational forces.

(2) Provost Marshal (PM). The PM will review and consolidate the designated restricted areas aboard the Combat Center on an annual basis. This consolidated list will be submitted to the CG for concurrence prior to the last working day of February or a date as intended for updated publication.


(3) Enclosure (1) will only be released to COs, ACs/S, OICs, Special Staff Officers, Security Officers/Managers, or their properly authorized designees. To request a copy of the enclosure, contact PMO, Physical Security Department at (760) 830-4561.
