Subj: CONSOLIDATED LIST OF RESTRICTED AREAS

Encl: (1) Consolidated List of Designated Restricted Areas

1. Situation. Reference (a) requires that the installation commander publish an annual consolidated list of all restricted areas aboard the installation, including all tenant command restricted areas.
2. Mission. To publish a listing of all restricted areas, including all tenant command restricted areas, aboard Marine Air Ground Task Force Training Command (MAGTFTC), Marine Corps Air Ground Combat Center (MCAGCC).
3. Execution
 - a. Commander's Intent and Concept of Operations
 - (1) Commander's Intent. To ensure the review, concurrence, and signature of the Consolidated List of Designated Restricted Areas, which will be designated Controlled Unclassified Information.
 - (2) Concept of Operations. All commands, organizations, units, and activities will provide a list of all restricted areas to the Commanding General (CG) via the Provost Marshal's Office.
 - b. Subordinate Element Missions. All originating offices that have designated restricted areas will comply with the intent of the references and the content of this Bulletin.
 - c. Coordinating Instructions
 - (1) Commands, Organizations, and Units. All Commanding Officers (COs), Assistant Chiefs of Staff (ACs/S), Officers-in-Charge (OICs), and Special Staff Officers are required to read the policies and guidance for restricted areas within the reference and publish in writing, an annual list of all restricted areas under their jurisdiction and control.
 - (2) Provost Marshal's Office (PMO). The Provost Marshal will review and consolidate the designated restricted areas aboard MAGTFTC, MCAGCC on an annual basis. This consolidated list will be submitted to the CG for concurrence prior to the last working day of February.


