- 1. Situation. The Commanding General, Marine Air Ground Task Force Training Command (MAGTFTC), Marine Corps Air Ground Combat Center (MCAGCC) has directed the Director, Government and External Affairs (GEA) to support the Morongo Unified School District (MUSD) Military Students Tour on 23 Apr 2024. This event is designed to promote military recruitment in the local high schools. It will provide Junior Reserve Officers' Training Corps students and others interested in joining the military a hands-on Marine Corps experience with information on military occupational specialties and physical fitness requirements. Students will have a signed hold harmless waiver from a parent or responsible quardian prior to event. Recruiters will be present to answer questions.
- 2. Mission. To support the recruiting mission and positively promote military careers to MUSD students.

3. Execution

Commander's Intent and Concept of Operations

- (1) Commander's Intent. To maintain positive relations between the Combat Center and the students/families in MUSD, as well as promote recruitment in the area. MAGTFTC, MCAGCC will provide personnel, resources, and equipment to support this event.
- (2) Concept of Operations. The units participating in this event will provide MUSD students the opportunity to learn about life in the Marine Corps, military training, tactical vehicles, and career opportunities in the military.

b. Subordinate Element Missions

- (1) Director GEA. Via the Operations Officer, serve as the event coordinator and liaison between MUSD and the Combat Center.
- (a) Communication, and Strategy Operations. Provide appropriate media coverage for the day of the event.

- (b) Marine Corps Community Services, Semper Fit. Request obstacle course demonstration and the use of Del Valle Field for this event.
- (c) <u>Center Logistics Division</u>. Provide support and authorization for students, teachers, and non-active-duty employees to eat their noon meal at the Dunham Mess Hall at the student rate for subsistence.
- (3) <u>Assistant Chief of Staff G-3/5/7</u>, <u>Marine Air Ground Task Force</u>, Training Directorate
- (a) Exercise Support Division. Provide vehicles for static display.
- (b) $\underline{\text{Explosive Ordnance Disposal}}.$ Request display and demonstration.
- (5) $\underline{\text{CO, 7th Marine Regiment}}$. Request static display, Marine Corps Martial Arts Program (MCMAP), infantry and Corpsman demonstration.

c. Coordinating Instructions

- (2) On 23 April 2024, students from MUSD will arrive to the installation for a day of military fun. Their day will begin with rotating static display demonstration stations at Del Valley Field. At 1045, students will form a group and observe two demonstrations back-to-back, the K9 Demonstration and the Semper Fit Obstacle Course followed by lunch at the Phelps Mess Hall.
- (3) To support the events on 23 April 2024, Marines, Sailors and civilians participating in the Military High School event will set up their individual static displays at Del Valle Field near the Semper Fit Obstacle Course (Site map for displays will be provided by the AO). The PMO/K9 Demonstration and the Semper Fit Obstacle Course will not have rotating stations, this will happen at 1045. Once the event concludes at Del Valle, the Marines, Sailors and civilians may join the group at the Phelps Mess Hall or return to their sections to carry out the plan of the day.
