Subj: INSTALLATION WIDE CLASS V AMNESTY DAY

- 1. <u>Situation</u>. In accordance with the above references, the Marine Air Ground Task Force Training Command (MAGTFTC), Marine Corps Air Ground Combat Center (MCAGCC) will conduct an Installation-wide Amnesty Day to recover Class V material that may be outside of the government's control. This Amnesty Day is open to all installation and tenant commands aboard the Combat Center.
- 2. <u>Mission</u>. From 0800 to 1300 on Friday, 24 October 2025, MAGTFTC, MCAGCC Explosives Safety Officer (ESO) will conduct an Installation-wide Amnesty Day. This Amnesty Day is open to all installation and tenant units residing aboard the Combat Center.

3. Execution

a. Commanders Intent and Concept of Operations

(1) Commander's Intent

- (a) To provide an avenue for those that may be in wrongful possession of Class V material, this Amnesty Day will provide a means to return Class V material to the government with no recourse. For this Amnesty Day to be successful, turn-ins shall be made without fear of punitive action. Therefore, individuals making amnesty turn-ins are normally not subject to investigation.
- (b) This Amnesty Day is not intended to circumvent the ammunition management process. Units discovering ammunition after having completed their turn-ins and having their accounts reconciled are not authorized to use the amnesty process. These units shall make amended turn-ins.

(2) Concept of Operations

(a) This Amnesty Day will take place at the Center Magazine Area (CMA) Classification Yard, see enclosure (1) from 0800 to 1300 on Friday, 24 October 2025.

- (b) For this Amnesty Day to be successful, all turn-ins will be made without question or fear of punitive action.
- (c) All Commanders are requested to allow participation as necessary with no questions asked.

b. Subordinate Element Missions

(1) Assistant Chief's of Staff (ACs/S), Commanding Officers (COs), and designated Special Staff Officers. Allow personnel to participate as required.

(2) Director, Mission Assurance

- (a) The MAGTFTC, MCAGCC ESO will coordinate the execution of the $\mbox{Amnesty Day}$.
- (b) The MAGTFTC, MCAGCC ESO will monitor the event to ensure all requirements within the references are continually met.
- (c) Explosive Ordnance Disposal will have two personnel on standby to assist if necessary.
- $\,$ (d) In the event of an emergency or a significant issue outside the scope of the requirements and this LOI, the ESO will make notifications to appropriate First Responders.

(3) AC/S, G-4, Installation Support

(a) Center Logistics Division

- $\underline{\textbf{1}}.$ The CMA will provide space in the Classification Yard to conduct Amnesty Day.
- $\underline{2}$. Provide two Ammunition Technicians to assist with Amnesty Day.
- (b) $\underline{\text{Environmental Affairs}}$. Range Sustainment Branch will provide empty ammunition cans of various sizes to accommodate returned ammunition. Unused ammunition cans will be returned with appropriate paperwork.

(4) COs of Tenant Commands

- (a) <u>CO, Combat Logistics Battalion-7</u>. Request one qualified/certified Ammunition Technician to support Amnesty Day turn-ins.
- (b) $\underline{\text{CO, 7}^{\text{th}}}$ Marine Regiment. Request one qualified/certified Ammunition Technician to support Amnesty Day turn-ins.
- (c) Remaining COs are requested to allow participation without question.
