Subj: COMBAT CENTER UNIFORM AND CIVILIAN ATTIRE REGULATIONS FOR ARMED FORCES

PERSONNEL

1. Situation. To transmit new changes to the Order.

- 2. Execution. Update paragraphs 4.c.(11)(d)7.a., 4.c.(11)(d)7.b., and 4.c.(11)(d)15 of the Order.
- 3. $\underline{\text{Summary of Changes}}$. This revision contains three administrative changes as follows.
- a. Update paragraph 4.c.(11)(d)7.a. to read \underline{a} . When aboard MCAGCC Installation, civilians may wear appropriate headgear indoors
- b. Update paragraph 4.c.(11)(d)7.b. to read $-\underline{c}$. Wearing headgear backwards, crooked, and/or cocked is prohibited. All service members will remove all headgear when indoors. The wearing of a bandana or "durag" with civilian attire is not authorized. Women may wear appropriate headgear while indoors IAW norms.
- c. Update paragraph 4.c.(11)(d)15 to read $-\frac{15}{2}$. Authorized patrons using the facilities and equipment at the Combat Center gymnasiums will wear athletic clothing and athletic shoes. Civilian authorized patrons are authorized to wear appropriate civilian headgear. The wearing of "durags," skull caps, bandanas, etc. is not authorized; however, wearing a hood attached to a hooded coat, shirt, or sweatshirt is authorized.
- 4. <u>Filing Instructions</u>. File this transmittal as the first page of the Order immediately.

Subj: COMBAT CENTER UNIFORM AND CIVILIAN ATTIRE REGULATIONS FOR ARMED

1. <u>Situation</u>. United States Marines and military service members are expected to wear uniforms and civilian attire both on and off base in accordance with good order and discipline. While on base, civilian employees and family members are also expected to uphold the same standard.

- 2. Cancellation. CCO 1020.11Y.
- 3. <u>Mission</u>. All Marine Air Ground Task Force Training Command (MAGTFTC), Marine Corps Air Ground Combat Center (MCAGCC) personnel and tenant commands living, visiting, and/or training aboard the Combat Center will conform to the uniform and clothing regulations set forth in this Order and its references.

4. Execution

a. <u>Commander's Intent and Concept of Operations</u>. The purpose of this Order is to provide the direction on uniform regulations encompassing both military personnel and civilian patrons aboard the Combat Center, ensuring a unified and respectful environment. This CCO applies to both civilians (e.g., employees, dependents, family members, etc.) and active-duty military. It is every Servicemember's responsibility to police and endorse the regulations set forth herein.

b. Subordinate Element Missions

(1) MAGTFTC, MCAGCC Sergeant Major

- (a) Provide guidance to the staff as required and enforce compliance of this Order to carry out the Commanding General's (CG's) intent.
- $\,$ (b) Review this Order annually and update it as required to enforce the CG intent.
- (2) <u>Assistant Chiefs of Staffs, Special Staff Officers, Commanding Officers, Officers-In-Charge</u>
- (a) Promulgate the contents of this Order to all personnel assigned to your command, directorate, section, and/or office.

- $\mbox{\ensuremath{\mbox{(b)}}}$ Ensure the contents of this Order are disseminated to all incoming personnel.
- (c) Post a copy of this Order in a prominent place on unit bulletin/troop information boards.
- (d) Ensure all Marines and Sailors in your command adhere to the standards set forth and identified in this Order and the references both on and off the Combat Center.
- (3) <u>Combat Center Facility Managers</u>. Display the proper dress code for your facility.

c. Coordinating Instructions

- (1) <u>Identification</u> (ID) <u>Cardholder Responsibilities</u>. Per reference (j), enclosure (1), all ID card holders will always carry their ID card. Personnel will be required to surrender the ID card when a military or civilian authority requires it for identification, investigation, when in confinement, upon discharge, or because of card expiration.
- (2) <u>Performance and Conduct</u>. Per reference (k), enclosure (1), United States Marines are characterized by exceptionally high standards of performance and conduct which reflect unswerving loyalty to the nation, devout attention to duty, and gentlemanly/ladylike demeanor. All Marines are expected to maintain these standards in the performance of their duties and the conduct of their personal affairs. Marine Corps standards don't stop when the uniform comes off. Marines are required to uphold standards consistently, both in and out of uniform, around the clock.
- (3) <u>Punitive Action</u>. This Orders applicability to military personnel is intended to be enforceable against individuals without further implementation by subordinate commands. Violations of the provisions of this Order by military personnel may result in administrative or punitive action and are punishable as a violation of Article 92 of the Uniform code of the Military Justice. Servicemembers and retirees who fail to conform to the proper dress standards outlined in this Order and reference (1) risk losing their on-base privileges (i.e., access to the Marine Corps Exchange (MCX), commissary, gyms, etc.).

(4) Grooming Standards

- (a) Grooming standards will be strictly adhered to in accordance with (IAW) reference (a) and (b), enclosure (1). The following is provided for emphasis. The requirement for hair regulations is to provide direction for maintaining a neat and professional military image.
- (b) $\underline{\text{Male Standards}}$. Male hairstyles require non-eccentric and non-faddish styles, maintaining a conservative, professional appearance. Hair will be neat and closely trimmed.
- $\underline{\textbf{1}}$. Hair, which protrudes from beneath properly worn headgear in an unsightly manner, is considered excessive, regardless of length.
- $\underline{2}$. Hair will be neat and closely trimmed. The hair may be clipped at the edges of the side and back and will be evenly graduated all

the way around the head (blended or faded and not edged as an outline) from zero length (skin) at the hairline to at least the top orifice of the ear circling around the back of the head, where it may then extend to the maximum hair length. Hair will not be over three inches in length fully extended (an extended hair, not the style, determines proper length) on the upper portion of the head.

- $\underline{3}$. The face will be clean-shaven, except for a mustache may worn. When worn, the mustache will be neatly trimmed and must be contained within the lines of B-B', C-C', D-D' and the margin area of the upper lip, as shown in figures 1-1 and 1-2 of reference (a), enclosure (1). The individual length of a mustache hair fully extended must not exceed 1/2 inch.
- $\underline{4}$. Except for a mustache, only the eyebrows and eyelash hair may be grown on the face unless when a medical officer has determined that shaving is temporarily harmful to the individual's health. In these cases, see reference (g), enclosure (1) and MARADMIN 124/25.

(5) Prescribed Uniforms

- (a) <u>Uniform of the Day</u>. The only prescribed working uniforms for Marines stationed aboard the Combat Center are desert Marine Corps Combat Utility Uniform (MCCUU) sleeves down, tanker/combat vehicle crewman (CVC) suit, flight suit, and Service "A", "B", or "C" uniforms. See reference (e) and (f), enclosure (1) for further information.
- (b) $\underline{\text{MCAGCC Waiver}}$. Reference (o), enclosure (1) prescribes the wear of other uniforms as directed per reference (i), enclosure (1).
- (c) The seasonal leave and liberty uniform throughout the year is the Service "A", "B", or "C" uniform. Consistent with mission and specified activities, commanders are delegated the authority to determine the frequency with which the Service uniform will be worn; but any plan should include a method to routinely check the fit and serviceability of the Service uniform for Marines within the unit, either through inspections, duty, community events, or designated periods of wear as the uniform of the day.
- (d) <u>Colors Ceremony</u>. The prescribed uniform for the morning colors ceremony is the desert MCCUU or Seasonal Service Uniform.
- (e) Commuting To and From Place of Duty. References (a) and (b), enclosure (1) authorize the wear of utility uniforms for commuting to and from the workplace. IAW references (e) and (f), enclosure (1), the following is a list of "off-base" authorized stops: drive-through windows at banking institutions, drive-through eating establishments, and drive-up automatic teller machines. In all cases, Servicemembers attired in the utility uniform (MCCUU, CVC, or flight suit for the purpose of this Order) will not exit the vehicle. The wear of the green, white, or blue coveralls or the mess hall uniform is not authorized for wear during any "off-base" authorized stops as outlined above.
- (f) Accessories in Uniform. While wearing the prescribed working uniform, articles that are not authorized to be worn exposed include, but are not limited to: pencils, pens, watch chains, fobs, pins, earphones and headphones, or anything else that detracts from a professional appearance. Hearing aid devices and conservative head or

earphones are authorized when necessary. Inconspicuous jewelry such as a wristwatch and ring is authorized. Inconspicuous rings are authorized for wear in uniform. When worn, only one ring is authorized per hand, except for wedding and engagement rings (when worn on the same finger they will count as one ring) and will be worn on the base of the finger close to the palm. Rings will not be worn on the thumbs. Sunglasses will not be worn in formation with troops, unless certified by a medical authority and must be IAW reference (a). Cartridge belts, holsters, lanyards, and helmets are only authorized when worn as organizational clothing and equipment. Cellular phones are not to be visible while in uniform (i.e., wearing cell phone on the utility belt).

- (g) <u>Electronics</u>. Personally owned, organizationally issued, and other electronic equipment will not be worn exposed on Marine Corps uniforms. The use of cellular phones or other electronic devices while walking in uniform, or while in formation, is not authorized. Good judgment is expected to govern the application of this policy in the field environment.
- (h) <u>Boonie</u>. The combat utility field cap (boonie) and Flame-Resistant Organizational Gear suits are ONLY authorized for wear on main side, during the execution of Service Level Training Exercise's by units identified as actively participating in these events. Serviceability and cleanliness of uniforms will be strongly adhered to per reference (a).
- (i) <u>Watch Cap</u>. The Defense Supply Center issued coyote watch cap may be worn with the physical training uniforms and the MCCUU in garrison and in the field when weather appropriate. When in a non-tactical or garrison environments, Marines will maintain the same saluting requirements as if wearing the garrison MCCUU caps. Marines will not salute when wearing the cold weather watch cap with the physical training uniform.
- (j) <u>Serviceable Uniform Items</u>. Excessively dirty, soiled, or torn uniforms do not meet acceptable attire standards within base facilities or working areas. Similarly, grooming standards must be upheld to ensure a professional appearance.
- (6) <u>Seasonal Uniform Change</u>. IAW reference (i), the seasonal uniform change will occur with the change to and from daylight saving time (DST).
- (a) Marines will continue to transition to the winter uniforms on the first Monday after the fall Daylight Savings Time (DST) change (1st Sunday in November), and to the summer season uniforms on the first Monday after the spring DTS change (2nd Sunday in March). During the winter season, the desert MCCUU will be worn with sleeves down and the designated Seasonal Service uniform will be Service "B."
- (b) Upon transition to the summer season, the desert MCCUU will still be worn with sleeves down and the designated Season Service uniform will be Service "C." The transition will occur the duty day following the change to or from DST.
- (c) $\underline{\text{Commander Direction}}$. Commanders overseeing units/personnel in training for deployment may set the MCCUU for wear based on the mission requirements, and as deemed necessary to ensure effective pre-deployment training.

- (d) $\underline{\text{Deployed Personnel}}$. Units and personnel deployed will adhere to the policy/guidance as established by combatant commanders and the regional Marine Forces commander. Military personnel visiting the Combat Center must adhere to these uniform regulations.
- (7) Wearing the MCCUU. The full MCCUU must be always worn. The partial uniform (boots and utilities) is authorized under the following conditions: when prescribed by unit commanders for the conduct of physical conditioning; when an individual is actively conducting individual physical conditioning; or as prescribed in this Order.
- (8) Wearing of Bags and Backpacks. IAW reference (h), enclosure (1), black, olive drab, brown, tan, or a combination thereof is authorized, or Marine Pattern commercial or organizational backpacks of a conservative nature, with minimal logo representation (i.e., manufacturer tags/logos in subdued colors no larger than five inches long by two inches wide), are authorized for wear over both shoulders with the MCCUUs. This authority does not extend beyond commercial/organizationally issued backpacks. Gym/duffel bags and computer bags will continue to be hand carried while wearing the utility or service uniforms.
- (9) Wearing of Individual Hydration Systems (Camelback). Due to the extreme hot weather experienced on the Combat Center, the wearing of an individual hydration system (Camel Back) in the utility or work uniform is authorized for both garrison and field duty. Government issued and civilian purchased hydration systems may be worn. The color shall be black, brown, green, or digital MCCUU camouflage. Personnel working in support of Tactical Training Exercise Control Group, Marine Corps Mountain Warfare Training Center, Marine Aviation Weapons and Tactics Squadron One, or Marine Corps Tactics and Operations Group, in a controller or assessor status, are authorized wear of a unit issued international orange hydration system.

(10) Miscellaneous Working Uniforms

- (a) Occupation Specific Uniforms. Cook, baker, and mess hall attendant uniforms will be worn as prescribed by reference (a), enclosure (1). Cook, baker, and mess hall attendant uniforms are authorized for wear to and from off-base quarters. These uniforms are not authorized for wear in the MCX and commissary.
- (b) <u>Civilian Attire vice Uniform of the Day</u>. Certain duty assignments aboard the Combat Center require the wearing of civilian clothing in lieu of the prescribed uniform. Except for Criminal Investigators, those personnel authorized to wear civilian clothing must be specifically authorized, in writing, by their Commanding Officer. Name tags will be worn with civilian clothing and placed over the right breast pocket. Name tags will conform to the specifications contained in reference (a), enclosure (1). An individual authorized to wear civilian clothing while on duty may be permitted to operate a government vehicle.
- (c) <u>Coveralls</u>. Green, white, and blue coveralls and CVC suits with a camouflage utility cover are authorized for personnel engaged in activities that have a potential to permanently soil or damage the utility uniform. When outdoors, the utility cap will always be worn and saluting requirements remain the same. Grade insignia will be worn on the coverall collar. The coverall uniform is authorized for wear in any mess hall

provided the uniform is clean and unsoiled. Coveralls are authorized for wear in places of work, to and from base quarters, and the Combat Center Landfill. The only personnel authorized to wear the coveralls off base are the wrecker operators engaged in recovery operations, and ambulance drivers. Wrecker operators engaged in recovery operations, and ambulance drivers. Wrecker operators are not authorized to make any stops for purposes other than emergencies, while wearing coveralls. The coverall uniform is not authorized for wear in the MCX or commissary.

- (d) <u>Uniform Trials</u>. Units or individuals may be designated to wear uniform items which are being tested for possible adoption. Commanders of such units or individuals will ensure widest dissemination of the fact that a wear test is being conducted. Such dissemination shall be made by bulletins published by the specific unit authorized to wear the test uniform or item, with a description of the uniform or item, and statement of the wear test period.
- (e) <u>Medical Appointments</u>. The prescribed uniform for medical appointments is the designated uniform of the day. The prescribed uniform for active-duty personnel reporting to military sick-call for physical examinations is either clean, standard-issue physical training gear (green on green) with athletic shoes and socks, or the prescribed uniform of the day.
- (f) Attire for the Conduct of Physical Training (PT). PT attire must be neat, clean, conservative in appearance, and reflect a professional image. Units conducting PT on the Combat Center will conform to the high standards traditionally associated with the Marine Corps. Reflective belts are required prior to morning colors and after evening colors per reference (c) and (d), enclosure (1). The Marine Corps Running Suit satisfies this requirement for individual PT sessions. For unit PT sessions, refer to reference (c) and (d), enclosure (1). Per references (a) and (g), enclosure (1), the designated uniform for unit PT is green on green T-shirt and green shorts with running shoes or green shirt with boots and utility bottoms. Authority to deviate from the designated uniform for unit PT attire will be the O-5/O-6 Commander but will be in keeping with the spirit and intent of this Order.

(11) Standards for Civilian Attire Aboard the Combat Center for Uniformed and Civilians

- (a) $\underline{\text{Applicability}}$. All uniformed personnel and civilians are required to comply with this Order when patronizing Combat Center facilities.
- (b) $\underline{\text{Enforcement}}$. Armed forces leaders at all levels will implement and enforce this Order. Officers, Staff Noncommissioned Officers, Noncommissioned Officers, Chief Petty Officers, and Petty Officers will become familiar with this Order. These individuals have responsibility for strict enforcement of this Order.
- (c) <u>Uncompliant Patron Removal</u>. If a uniformed member is addressed professionally and refuses to leave, or is excessively belligerent or rude, attempt to obtain the name and the individual's unit and contact Provost Marshall Office personnel for assistance in documenting the individual's name and sponsor, and to escort the individual out of the facility.

- (d) <u>General Guidance</u>. Not all circumstances involving civilian attire can be covered within the guidelines below. Every individual should take pride in his/her appearance and observe common sense standards of cleanliness, decency, neatness, and safety. Prior to wearing an article of civilian attire, personnel should ask themselves, "Is the item authorized? Is it clean? Is it serviceable? Is it within good taste? Does it project a favorable image?" Appropriate civilian attire for wear in public buildings/facilities at the Combat Center will be as follows:
- 1. Privilege. The wearing of civilian clothing by military personnel is a privilege extended by the Commandant of the Marine Corps. Marines are associated and identified with the Marine Corps in and out of uniform, and when on or off duty. Therefore, when civilian clothing is worn, it is expected Marines will ensure their dress and personal appearance is conservative and commensurate with the high standards traditionally associated with the Marine Corps. The wearing of earrings by male Marines is prohibited on and off base. Male Sailors will not wear earrings aboard the Combat Center.
- $\underline{2}$. Revealing Clothing. Excessive amounts of back, chest and midriff, or items designed to be worn as undergarments (and worn exposed), such as boxer shorts, briefs, camisoles or slips, bralettes, bra straps, or "string tees," etc. are not authorized for civilian attire while on or off duty.
- $\underline{3}$. Belt Loops. When wearing trousers or shorts with civilian attire, a belt must be worn unless there are no belt loops.
- $\underline{4}$. $\underline{\text{Undergarments}}$. Will not be visible, except as when the undershirt is exposed in a manner like the service "C" uniform. Adequate undergarments will be worn to ensure proper fit, appearance, and eliminate transparency of clothing worn.
- $\underline{5}$. Other Civilian Attire. Includes undershirts and should be worn as appropriate to the occasion (i.e., bathing suit/bikini appropriate to the beach/pool, but not to the Marine Corps Exchange). Trousers and skirts will be worn at the waist. Civilian sweat gear designed for working out is not authorized within any of the service clubs or base facilities, unless it is your duty uniform, e.g. Semper-Fit, Lifequard official uniform.
 - 6. No eccentricities of dress will be permitted.

7. Civilian Headgear

- \underline{a} . When aboard a military installation, civilian headgear will be removed indoors in accordance with reference (m) and (n), enclosure (1). When aboard MCAGCC Installation civilians may wear appropriate headgear in doors. Common sense will prevail for bona fide medical and religious exceptions.
- $\underline{\textbf{b}}.$ Will be worn in the same manner as the utility uniform cover.
- <u>c</u>. Wearing headgear backwards, crooked, and/or cocked is prohibited. <u>Males will remove all headgear when indoors</u>. All services members will remove all headgear when indoors. <u>Common sense will prevail</u>

for bona fide medical and religious exceptions. The wearing of a bandana or "durag" with civilian attire is not authorized. Women may wear appropriate headgear while indoors IAW social norms.

- $\underline{8}$. Appropriate Casual Wear. Military personnel must wear trousers, shorts, and skirts that are clean and presentable. Trousers featuring frayed areas on the legs are not permitted.
- $\underline{9}$. Sandals. Authorized for wear as appropriate civilian attire; however, plastic sandals/shower shoes are not authorized. Authorized sandals may be worn in mess halls. When utilizing the gymnasiums proper footwear is required. Bare feet or socks only is not authorized.
- 10. Appropriate Length of Attire. Excessively high-cut shorts, dresses, or skirts are prohibited. Shorts, dresses, or skirts will fall at mid-thigh as to allow reasonability to all body types.
- $\underline{\text{11.}}$ Civilian PT Gear. Authorized to be worn under the following exceptions for Military:
- <u>a.</u> Child, Youth, & Teen Programs. Authorized for drop-off and pick-up of children only. However, the conducting of business or attending any event in PT/aerobic attire is strictly prohibited.
- \underline{b} . Base Gas Station. Purchasing of gasoline is only authorized via payment rendered at the pump (PT, including civilian sweat gear is not authorized inside the building, unless official uniform Semper-Fit, Lifeguard official uniform).
- $\underline{\text{c. Walk-Up Windows}}. \text{ Marines and Sailors are authorized to use the walk-up window of the dining facilities while wearing the prescribed physical fitness uniform. Under no circumstances will meals be consumed nor is loitering allowed; the meal will be obtained, and the individual shall depart the facility immediately. The dining facility manager has the discretion to allow a temporary exception to the consuming of meals while in physical fitness attire outside the facility only. No long-term exception will be allowed without the prior approval of CG, MAGTFTC, MCAGCC.$

12. Alterations

- <u>a. Fitting.</u> Unless worn in a manner otherwise authorized in this Order, civilian slacks, trousers, shorts, and skirts with eccentric alterations that accentuate private anatomical parts or are excessively, short, tight, or baggy fitting are prohibited. All slacks, shorts, and trousers shall be worn so that neither undergarments nor private anatomical parts are revealed.
- <u>b</u>. Appropriate Style. Shirts and blouses with eccentric alterations that accentuate private anatomical parts, or expose undergarments or are excessively, short, tight, or baggy fitting are prohibited. Male or female midriffs shall not be visible, except as noted below. Shirts and blouses will be clean. The size and fit of the shirt and blouse will mirror a neat appearance. Shirts and blouses may be worn un-tucked that do not hang below crotch level (unless it is a female tunic style blouse, designed to hang lower, and does not have a shirt

- tail). Uniform and civilian undershirts are not appropriate as outerwear. This includes green skivvy shirts and unit PT type T-shirts. Also prohibited, as outerwear, are all tank top style shirts, halter-tops, String tees, tube-tops, and swimsuit tops. Such clothing is acceptable only while at the pool or beach. Formal and semi-formal gowns, sundresses, and similar styles of female clothing that are sleeveless are considered appropriate attire. Professional sports jerseys with sleeves are acceptable, but they must fit in size and not be overly baggy. The wearing of excessively oversized shirts detracts from a neat appearance.
- <u>c. Messaging</u>. Civilian shirts with eccentric alterations or which include, but are not limited to the following, are prohibited from wear as outer garments: inflammatory words; pictures; symbols, or print which is profane, offensive, supremacist, racist, sexually suggestive, obscene, or supportive of, or oriented toward the glamorization of drug abuse or any illegal activity are prohibited. Furthermore, any attire that is derogatory toward any sex, ethnicity, religious group, military service, the flag or symbol of any people or group is prohibited.
- $\underline{13}$. Reflective Belts. Required prior to morning colors and after evening colors while conducting individual PT in civilian PT gear per reference (d), enclosure (1). The Marine Corps Running Suit satisfies this requirement for individual PT sessions. For unit PT sessions, refer to Chapter 3 of reference (d), enclosure (1).

14. Electronic Devices

- \underline{a} . Wearing any electronic listening device while in uniform is prohibited. Earphones and headsets are not allowed to be worn with any combination of uniform, partial uniform, or Marine Corps PT uniform (i.e., green on green and the Marine Corps running suit).
- \underline{b} . When wearing civilian clothing and playing a radio or any other electronic device, the volume will be kept low enough so as not to disturb others in the immediate vicinity. Radios, iPods, MP3s, or any electronic device will not be played in Combat Center public facilities unless personal earphones are utilized.
- <u>c</u>. The wearing of headphones, earphones, or other listening devices while walking, jogging, running, skating, skateboarding, bicycling, or using a personal transportation device on or within three feet of clearance of any traveled portion of any street, roadway, highway, avenue, vehicle/tank trail, or parking lot is prohibited. This includes when crossing any of the above, even if in a crosswalk (i.e., listening devices must be removed from the ears). Listening devices may be utilized while on a running/walking track, sidewalk, PT field, or designated pathway. Pedestrians are responsible to ensure that they always face traffic and maintain a minimum of three feet from the traveled portion of streets, roadways, vehicle/tank trails, or parking lots or are otherwise protected from traffic (e.g., curbed sidewalk, pedestrian bridge, etc.).
- 15. Standards for beneficiaries, retirees, civilian contractors, and other dependents utilizing the Combat Center Gymnasiums. Authorized patrons using the facilities and equipment at the Combat Center gymnasiums will wear athletic clothing and athletic shoes. Civilian headgear is not authorized in the weight rooms or gymnasiums (common sense will prevail for bona fide medical and religious exceptions). Civilian authorized

patrons are authorized to wear appropriate civilian headgear in the weight rooms or gymnasiums. Specifically, The wearing baseball caps, of "durags," skull caps, bandanas, etc. is not authorized; however, wearing a hood attached to a hooded coat, shirt, or sweatshirt is authorized.

- $\underline{16}$. Emergencies. During the handling of bona fide emergencies in either the medical or the dental clinics, the standards of dress prescribed by this Order are waived.

6. Command and Signal

- a. $\underline{\text{Command}}$. This Order is applicable to all active duty and reserve Armed Forces personnel, and all tenant organizations aboard the Combat Center.

- 2. Reference (b) sets forth uniform regulations for Navy personnel. The uniform of the day and authorized alternate uniforms are prescribed by the Naval Area Coordinator, Commander Naval Base, San Diego, as modified by this Order.
- 3. References (c) and (d) set forth current policies regarding traffic safety (to include pedestrian and bicycle safety) for the Marine Corps and assigned Navy personnel.
- 4. References (e) and (f) provide direction on the wearing of the Marine Corps Combat Utility Uniform (MCCUU) [also contained in reference (a)].
- 5. Reference (g) provides direction for the wear of the Marine Corps physical training (PT) uniform and the Marine Corps running suit [also contained in reference (a)].
- 6. Reference (h) provides direction for the wear of commercial bags worn with the MCCUU.
- 7. Reference (i) provides information on the MCCUU sleeve position worn sleeves down year around; specified commanders are the seasonal uniform, field, training, and deployment dictating authority.
- 8. Reference (j) provides information regarding Real-time Automated Personnel Identification System (RAPIDS) issuing sites and the Defense Enrollment Eligibility Reporting System (DEERS).
- 9. Reference (k) is binding upon all persons in the Department of the Navy in matters concerning Marines and the Marine Corps.
- 10. References (l), (m), and (n) are updates in result to the Marine Corps Uniform Board and uniform regulation updates.
- 11. Reference (o) is the Combat Center seasonal uniform waiver.
