1. <u>Situation</u>. Per the references, to promulgate the Commanding General's (CG) policy, procedures, and guidelines pertaining to the discipline and law enforcement regulations aboard the Marine Air Ground Task Force Training Command (MAGTFTC), Marine Corps Air Ground Combat Center (MCAGCC), which will be further addressed as the "Combat Center." This Order should be reviewed in its entirety by all personnel aboard the Combat Center.

2. Cancellation. 1630.6C.

3. <u>Mission</u>. To implement the references, and to define, clarify, and establish local policies and procedures relative to the discipline and law enforcement aboard MAGTFTC, MCAGCC. Reference (u) is to be followed by Commanding Officers (COs), Assistant Chiefs of Staff (ACs/S), Special Staff Officers, Division Directors (DivDirs), Officers-in-Charge (OIC), personnel, and residents aboard the Combat Center.

4. Execution

a. Commander's Intent and Concept of Operations

(1) <u>Commander's Intent</u>. To establish guidelines and procedures regarding discipline and law enforcement aboard the Combat Center.

(2) <u>Concept of Operations</u>. To establish responsibilities and procedures which govern the conduct of personnel and activities aboard the Combat Center. These regulations are a general order and punitive in nature, and the violation of which may result in disciplinary or punitive proceedings.

b. Subordinate Elements Missions

(1) COs, ACs/S, DivDirs, Special Staff Officers, and OICs. Ensure that all personnel are familiar with the contents of this Order, and reference (u).

(2) <u>AC/S Installation Support Directorate, Mission Assurance, Provost</u> Marshal's Office (PMO)

(a) Responsible for establishing local instructions for the discipline and law enforcement aboard the Combat Center.

(b) Ensure reference (u) is reviewed annually, and complies with higher level directives contained in the references.

5. Administration and Logistics

b. Forms. Common Access Card (CAC) is required. All former editions are obsolete and will not be accepted.

6. Command and Signal

a. <u>Command</u>. This Order is applicable to all military personnel, civilian employees, and visitors while aboard the Combat Center.
