(e) Telecommunications Design Standards

- 1. <u>Situation</u>. The Assistant Chief of Staff (AC/S), G-6 Communications is responsible for all telecommunications and information systems aboard the Combat Center. These systems are governed by Public Law, as well as, the Department of Defense (DoD), Department of the Navy (DON), and service orders, policies, procedures, and directives. Reference (a) establishes the governing policy for Unified Capabilities products and services supported on DoD networks. Reference (b) provides U.S. Marine Corps (USMC) policy and procedures for real property facilities, of which telecommunications infrastructure and facilities are a part. Reference (c) provides USMC policy for installation geospatial information and services. Reference (d) establishes the localized Cybersecurity policy. Telecommunications and information systems policy is also included in DoD, DON, and service directives in the 2000, 5000, and 8200 series. This Order and reference (e) provides guidance and procedures in the management of telecommunications design standards for the Combat Center.
- 2. Cancellation. CCO 2010.1F.
- 3. <u>Mission</u>. In accordance with (IAW) the references, implement the design, installation, and operating standards for telecommunications and information systems for all information technology fixed plant resources procured, developed, operated, maintained, or managed aboard the Combat Center.

4. Execution

- a. Commander's Intent and Concept of Operations
- (1) <u>Commander's Intent</u>. To implement comprehensive telecommunications and information systems design, installation, and operating standards for all fixed plant communications, information systems, and associated infrastructure hosted by the Combat Center to ensure efficient, effective, and compliant design, installation, operation, and full

life-cycle support. All command fixed plant telecommunications systems and associated infrastructure must be compliant with DoD, Defense Information Systems Agency Global Information Grid/DoD Information Network (DoDIN), DON, and Marine Corps Enterprise Network (MCEN) policies and standards.

(2) Concept of Operations

- (a) Telecommunications infrastructure and information systems are tasked to the command and installation Chief Information Officer/Senior Telecommunications Manager. For the Combat Center, that oversight is assigned to AC/S, G-6 Communications. A key function of telecommunications and information systems oversight is the comprehensive management of existing and new telecommunications, and/or information systems from design, installation, operation, and their resulting full life-cycle support.
- (b) All fixed plant telecommunications infrastructure and information systems require service and command assessment and authorization, prior to being granted authority to operate (ATO) and, when necessary, integration into the MCEN and/or DoDIN, via an authority to connect (ATC). The Authorizing Official is the issuing authority for an ATO and ATC.

b. Subordinate Element Missions

- (1) Commanding Officers, ACs/S, Division Directors, and Special Staff Officers. Ensure all telecommunications infrastructure and information systems hosted by their respective organizations are coordinated through G-6 Communications and are designed, installed, and operated through their life cycle, IAW reference (e).
- (2) $\underline{AC/S}$, $\underline{G-6}$ Communications. Implement and administer all approved telecommunications design standards IAW higher headquarters policy and reference (e).
- (3) $\underline{AC/S}$, $\underline{G-4}$ Installation Support. Ensure telecommunications infrastructure and information systems support for all military construction and facility sustainment and restoration projects are coordinated through $\underline{AC/S}$, $\underline{G-6}$ Communications.

5. Administration and Logistics

- c. Any deviation from the Telecommunications Design Standards must be approved by the AC/S or Deputy AC/S G-6 Communications.
