ON 16 MAY 2009, AN ENHANCED MARKSMANSHIP PROGRAM (EMP) DECK SHOOT WAS CONDUCTED ABOARD USS DUBUQUE BY MEMBERS OF BATTALION LANDING TEAM 2/5. AMMUNITION TO BE FIRED FOR THIS DECK SHOOT TOTALED 10,080 ROUNDS OF A059 CTG 5.56MM BALL. EACH MARINE RECEIVED ONE BOX OF (30) A059 CTG 5.56MM BALL AND TWO ADDITIONAL STRIPPER CLIPS OF (10) A059 BALL EACH, TOTALING {50) A059 CTG 5.56MM BALL. SHORTLY AFTER AMMUNITION WAS ISSUED FROM MANUFACTURED SEALED WOODEN BOXES AND AMMO CANS, THE RANGE SAFETY OFFICER (RSO) WAS APPROACHED BY A MARINE WHO HAD BEEN ISSUED AMMUNITION INQUIRING IF IT WAS INTENDED THAT HE RECEIVE BLANK AMMUNITION. THE RSO DISCOVERED THE MARINE HAD BEEN ISSUED {40} A059 CTG 5.56MM BALL AND (10) A080 CTG 5.56MM BLANK. THE RSO TOOK POSSESSION OF THE (10) A0B0 CTG 5.56MM BLANK AND PROVIDED THE MARINE WITH {10) A059 CTG 5.56MM BALL. AFTER SEVERAL RELAYS PASSED, THE SAME SITUATION OCCURRED WITH ANOTHER MARINE. FOR A SECOND TIME THE RSO RETRIEVED THE (10) AOSO· CTG 5.56MM BLANK THAT HAD BEEN ERRONEOUSLY ISSUED AND PROVIDED THE SECOND MARINE WITH (10) A059 CTG 5.56MM BALL. AT THIS TIME, THE RSO BEGAN A THOROUGH INSPECTION OF ALL REMAINING ROUNDS TO BE ISSUED AND ORDERED ALL MARINES WHO HAD ALREADY BEEN PROVIDED AMMUNITION TO INSPECT THEIR AMMUNITION FOR BLANKS, NO OTHER A080 CTG 5.56MM BLANKS WERE FOUND MIXED WITH THE A059 CTG 5.56MM BALL.
