

# REGISTRATION

Personnel assigned to the Combat Center are required to have vehicle(s) registered within 3 working days of reporting, which requires copy/proof of:

*State Vehicle Registration*  
*Liability Insurance*  
*State Driver's License*

Personnel residing on the Combat Center are required to have personally-owned weapon(s) registered within 5 working days of reporting, which requires the following information:

*Year, Make, Model, Weapon Type*  
*Caliber, Barrel Length, Serial Number*  
*Markings (scratches, color, inscription)*

Documentation may be required:

*Proof of purchase if bought from MCX*  
*Command Letter if storing in unit armory*

Personnel residing on the Combat Center are required to register dogs and cats by:

*Description of animal*  
*Responsible owner data*  
*Evidence of rabies vaccination*

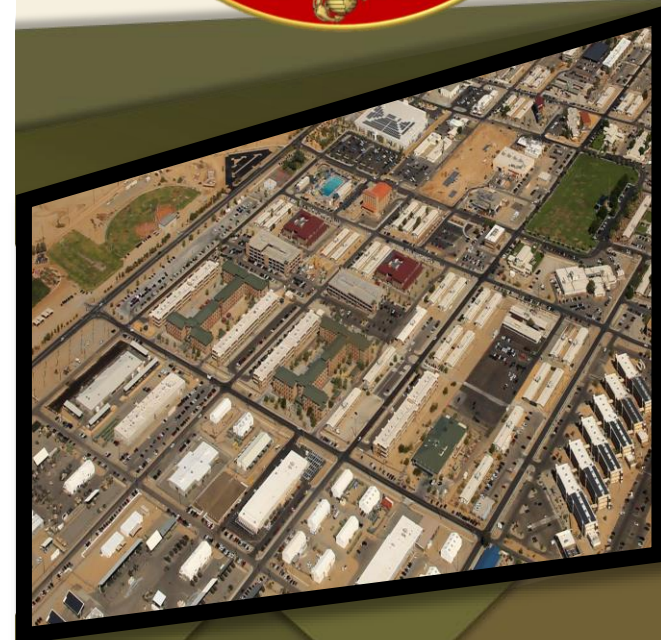

## ACCESS CONTROL

In order to access the Combat Center, all persons shall have an acceptable purpose for entry, present an approved and valid credential, and be subject to Marine Corps standards and methods to determine identity and fitness of the individual(s) requesting access.

Access is established as:

Unescorted Access applies to persons who have properly established identity, received a favorable fitness determination, and have an acceptable purpose for entry.

Escorted Access applies to persons who have established an acceptable purpose but do not meet further identity and source document(s) requirements.

See the included lists for identification documents and Combat Center regulations for registrations.

## IDENTITY

The following is approved identification:

- Common Access Card (CAC)
- USID Card (Retiree/Dependent)
- DBIDS Card
- REAL ID-compliant Driver's License
- Enhanced Driver's License
- United States Passport/Passport Card
- Foreign Passport (bearing Unexpired Immigrant, Non-Immigrant Visa, or Entry Stamp)
- Federal PIV Card
- Veteran's Health Identification Card
- Non-Federal PIV-I Card
- Transportation Worker Identification Card

Documents marked with "Not Valid for Federal Purposes", "Federal Limits May Apply", or any similar phrase require a second source identity document, such as:

- Birth Certificate (bearing raised seal)
- Social Security Card (not laminated)

## SPONSORSHIP

Permanent DoD personnel (Service Members, Dependents, Civilians, and approved DoD Contractors) above the age of 18 are authorized sponsorship of visitors, support services, and vendors.

As a sponsor you are accountable for the conduct of the individual(s) you sponsor. When escorted access is required, you are to have no more than five escorted guests.

Requests for greater than 50 guests will be treated as a Special Event.

All visitors must meet background screening requirements. Access will be denied if you are on/with:

Registered Sex Offender List  
Convicted of Sexual Crimes  
Convicted of any Felony  
Terrorist Watch List  
Wants/Warrants  
Debarred at/on other DoD Installations

*Remember, access to the Combat Center is a privilege extended by the Commanding General.*

*All identification must not be damaged, defected, or expired and must be original and current.*

*Other restrictions may apply depending on the situation.*
