## **Estate Planning**



### Who needs a will?

#### You might **NEED** a will if:

- -1) You have children and want to appoint a guardian; or
- -2) You have part ownership in a family farm or business; or
- -3) You have certain items which distributed to certain people
- You might **<u>NOT</u>** need a will if:
- -1) You are married, have no children, and want everything to go to your spouse; or
- -2) You are not married, have no children, and want everything to go to your parents in equal shares





### "Are you under any coercion, duress or undue influence?"



No one is allowed to order you to get a will
You <u>must</u> be freely entering into its terms
A will that is executed under duress can be voided



### May not need a will if . . .

### **Power of Attorney (POA)**



- Allows Person A (the principal) to grant Person B (the agent) the legal authority to act on Person A's behalf
- -Make business and financial decisions
- .Sell or register a vehicle
- .File taxes
- .Get a Credit Card
- .Sign a Lease
- -Take care of children

### **Types of Power of Attorney**



- General Power of Attorney: unlimited authority
- -Very risky and may be unnecessary
- -Some institutions may not even accept
- Special Power of Attorney: limited authority
- -Minimizes risk and accomplishes your intent
- -May want to use specific financial institution for specific powers
- Power of Attorney for the Care of Children (In Loco Parentis)
- -Designate someone to care for your child if neither biological parent is available to act as a parent
- Only temporary responsibility over the child, and does not change courtordered custody

### **General Power of Attorney**



A Marine designates his mother as his agent, and when he returns from deployment, he finds out that his mother has filed for divorce and served his wife with divorce papers

Marine designates his wife as his agent, and when he returns from deployment, he finds out she sold the house, emptied his bank accounts, and moved back home

Sailor designates his father as his agent, and when he returns from deployment, he finds out his father emptied his bank accounts, leased a truck at 25% interest, and accrued \$30,000 in credit card debt
