MGySgt Formosa memorial service today

A memorial service for Master Gunnery Sgt. Nicholas J. Formosa will be held at the base theater today at 9 a.m.

The uniform of the day and appropriate civilian attire is acceptable for the ceremony being held by Headquarters Battalion.

Formosa, a South Philadelphia, Pa. native and staff noncommissioned-officer-in-charge of Battle Simulations aboard the Combat Center, died in a motorcycle accident on Highway 62, July 27.


Formosa was born August 18, 1951, and graduated from Bishop Neumann High School in 1969. He joined the Marine Corps Reserve in 1970 during the Vietnam War.

Formosa has served in all four Marine Corps Divisions over the course of his 37-year career.

He has served in the Vietnam War, Operations Desert Shield and Desert Storm, and two deployments to Iraq in support of Operation Iraqi Freedom.

At age 55, Formosa was one of the oldest and longest-serving active-duty Marines in the Marine Corps.

He is survived by his wife of 28 years, Christina, and his son, Nicholas C. Formosa, 26.

India Battery tests new arty tech

The Marines of India Battery, 3rd Battalion, 11th Marine Regiment, became the first combat unit to conduct testing of the M982 Excalibur artillery round July 6-14 at Yuma Proving Grounds, Yuma, Ariz.

The Excalibur, a fire-and-forget round guided by a global positioning system will provide a new role for artillery units in urban warfare with its ability to guide itself to tar-

gets previously unreachable by other artillery rounds.

The new round also increases the effective range of the M777A2 howitzer from 30km to 40km and can strike within 10m of its target. If the round strays more than 30m away from its target, it will automatically become inert to minimize collateral damage.

"The way it works is by aiming the howitzer's tubes at a high angle," said Cpl. Kevin Collins, artillery cannoneer, India Battery. "The round acquires GPS signals from satellites once it reaches its peak height, then begins

dropping. As it drops, stabilizing fins pop out of the round and it glides down, guiding itself toward its target."

The Excalibur is designed to cooperate with the recently adopted Digital Fire Control System, which allows firing data to be relayed digitally, decreasing the possibility of human error via radio transmissions.

"We fire this new round digitally, which means my computer in the fire direction center talks to the guns, which in turn, talk to the round itself," said Sgt. Jonathan Smith, India Battery assistant ops chief.

The efficiency and accuracy of the Excalibur is expected to save both time and Marines on the battlefield.

"Instead of risking the lives of Marines to capture previously unreachable targets, we can now fire the Excalibur and take out those targets," said Sgt. Emmanuel Mireles, section chief, India Battery. "The main reason we have this round is to hit enemy targets without the possibility of collateral damage."

"One thing that's really great about

Band sergeant volunteers for new world

Have you ever wanted to do something out of the ordinary? Have you ever been caught by the urge to stray from the normal walk of life and run with something extraordinary?

Sgt. Regan A. Young, an Arlington, Va. native stationed at the Combat Center, wanted just that.

Young was assigned to the Combat Center Band for almost three years before he was granted temporary assigned duty with Headquarters and Service Company, 1st Battalion, 7th Marine Regiment.

"I want to be a part of what the Marine Corps is involved in," said Young. "I want to be able to see things for myself."

Because of Young's inability

to deploy while in the band, he requested to be assigned to an infantry unit so his aspiring hopes to go to Iraq could be made possible.

"I wasn't really getting the exposure I wanted," said Young about his experience with the band.

Because Marines from the band don't typically go to infantry battalions, it was a challenging task for Young to accomplish his plans.

Young constantly monitored his paperwork to ensure that his request would go through the right channels.

"If you want something, you have to go for it," he said. "If I didn't have that mentality, I'd never step foot in Iraq."

Although the band members were supportive of Young, it was difficult for them to lose a valued member of their ensemble.

"It was a tremendous impact on the band to lose Sgt. Young because he played a specialized instrument," said Staff Sgt. Joe Streeter, drum major, Combat Center Band.

Young participated in the band by playing both the saxophone and the oboe. His decision to leave the band was difficult because of the unique musical abilities he learned his whole life.

"If I were in a higher position in the band, it would be tough to watch one of my Marines go," said Young.

Almost six months after submitting his request, he had the approval of his chain of command to deploy with the Marines of 1/7.

"Once I was attached to 1/7, I was not only new, but completely out of my element," he said. "It was the complete opposite end of the

spectrum."

Young said that his first few months with H&S Company were hard to establish himself in any authoritative position because he was not as knowledgeable as the

Marines below him.

"Most transitions in life are hard, but this was a completely different world," said Young.

Paid-up SBP status now available

Arlington, Va. (31 July 2007) – Participants in the Uniformed Services Survivor Benefit Plan (SBP) for retired military members now have a new milestone to mark on their calendars.

Effective October 1, 2008, SBP participants who reach 70 years of age and have made 360 payments (30 years), will no longer have to pay premiums for continued SBP coverage and will be placed in "Paid-up SBP" status.

Paid-up SBP provisions were mandated by the National Defense Authorization Act (NDAA) for Fiscal Year 1999. The law also established a paid-up status, also beginning on October 1, 2008, for participants in the Retired Serviceman's Family Protection Plan once they reach 70 years of age.

No action is required of SBP participants to be placed in Paid-up SBP status. Once the eligibility criteria has been met, the Defense Finance and Accounting Service (DFAS) will automatically stop deducting premiums from qualifying military retired pay accounts.

The law establishing Paid-up SBP does not allow for refunds of premiums paid prior to October 1, 2008, even though a retiree may have

reached 70 years of age and made 360 or more premium payments.

DFAS is currently developing changes to the military retiree pay systems that will monitor the number of SBP premiums paid and the age of the participant. The system updates are targeted for a May 2008 completion date. At that time, SBP participants who will be eligible for Paid-up SBP status on October 1, 2008, or will meet eligibility within a short time of the implementation date, will be notified by mail of their impending Paid-up status.

Those military retirees who become eligible for Paid-up SBP status after the initial group will be notified of their SBP status on their December 2008 annual Retiree Account Statements (RAS) that will note the number of premiums paid to date. Each RAS issued after December 2008, whether annually or as a result of a pay change, will include the Paid-up SBP premium "counter," based on DFAS records, to help retirees monitor their eligibility status.

More information on Paid-up SBP, including frequently asked questions and news updates, should be available at the DFAS Web site (www.dfas.mil/retiredpay.html) within the next several months.

Why are these recalls happening?

While we have some of the most rigorous quality and safety testing procedures in the toy industry, no system can be perfect. If mistakes are made, we fix them. If new standards are set, we apply them.

What is Mattel doing to address this situation?

Regarding our manufacturing processes, we immediately strengthened them with a three-point check system. First, we're requiring that only paint from certified suppliers be used, and we're requiring that every single batch of paint at every single vendor be tested. If it doesn't pass, it doesn't get used. Second, we are tighten-

ing controls throughout the production process at vendor facilities and increasing unannounced random inspections. Third, we're testing every production run of finished toys to ensure compliance before they reach our customer. We've met with vendors to ensure they understand our tightened procedures and our absolute requirement of strict adherence to them.

What can I do, as a parent, to ensure my child's safety?

We want to ensure that every parent hears about these issues quickly and returns recalled toys to us as soon as possible. With other toys, always read the packaging for age grading and always monitor your child's play. If you have any doubts at all, please check with a pediatrician or other qualified medical professional.

Will there be more recalls?

We are in the middle of an extremely detailed and wide-ranging investigation. The fact that we were able to identify a specific part of one product as problematic is indicative of how painstaking this analysis is. We hope that we don't have to recall any more products, but if we do, we will address the matter promptly and inform you quickly.

How can I trust that Mattel toys are safe?

Our priority is the safety of the children who play with our toys. Mattel's philosophy is that every employee is responsible for the quality and safety of our products. Mattel has an organization of more than 1,500 people worldwide solely dedicated to the safety, quality and overall integrity of our toys, including more than 400 highly-trained engineers, technicians, auditors and managers who strive to meet the company's safety vision of providing "Quality and Value the World Can Trust." We are working around the clock to improve our system and have already taken significant actions to do so.


Register your weapons!

According to CCO P1630.6E, chapter 4, all weapons introduced to the Combat Center must be registered with the Provost Marshal's Office and conform to all California regulations for transport. Weapons can be registered at The Vehicle Registration Office located at the front gate Bldg 901. Personnel do not need to bring their weapon to the front gate only the serial number. Rifles, shotguns, pistols, bows, bb/pellet guns, paintball guns, air soft guns, swords, spears, and knives with a blade of over 4 inches are all considered weapons and must be registered. Additionally, you may obtain a free gun safety lock for your firearms at Vehicle Registration at any time. Failure to register weapons may result in punitive action and/or the confiscation of the weapon.

If you have any questions call the Vehicle Registration office at 830-6794.

The following services are available to on-base personnel and residents through Crime Prevention: literature, briefs, education, crime assessments, safety tips, the Stranger Danger program, McGruff the Crime Dog, the Officer Friendly program, the Property Marking program, and the Child Identification and Fingerprinting program. Career Resource Officer allows Marines to "TAP" into success

California Marines are responsible for 25 percent, or \$4 million of the unemployment rate given to Marines, said Virginia Sulick, Career Resources manager.

This staggering rate of money is taken directly out of the Marine Corps' training budget, said Sulick.

She explained that the Transition Assistance Program plays a direct and crucial role in preserving training money, as well as preparing Marines to re-enter the corporate world.

TAP is only the class portion of the entire Transition Assistance Management Program process, added Sulick.

The TAP process begins when an active service member meets with their unit's career retention specialist at various points throughout their enlistment. When the service member draws near the end of their active service and decides not to reenlist, he or she must then sign up for pre-separation counseling. If the service member decides to continue down the path of non-reenlistment, he or she then attends a pre-separation

brief held twice a month.

At the brief, guest speakers from various organizations including the Traffic Management Office, TRICARE Insurance, the California Employee Development Department, Veteran's Affairs and the Personal Finance Management Program brief the service members on aspects of getting out of the armed services.

"The subject matter experts come in and talk about what to expect during the process," said Sulick.

The next step is to attend the three-day course, commonly referred to as TAPs.

"When most service members enlist, they have not been initiated in the ways of the real adult world or the corporate market," said Sulick.

It is for this reason that the All-Marine Message 1700.24B was created.

The message states that all end-of-service Marines are required to attend TAP prior to their end-of-active-service date, per Gen. James T. Conway, Commandant of the Marine Corps.

The TAP course assists Marines in achieving success outside the Marine Corps through means of career field identification, resume-writing classes, job searching tech-

niques and many more.

"We highly encourage spouses to attend these classes, as well," said Sulick. "They are making a big transition, too."

Programs like the Family Member Employment Assistance Program are specifically designed to help dependents the same way TAP helps active duty service members.

"We are not just limited to this program," said Sulick about the Career Resource Office's role in TAP. "We have many programs and classes like the dress for success class, which we offer on an as-needed basis through TAMF."


Dennis Warren, TAP coordinator, agreed, saying the purpose of TAP is to ensure successful connections are made during the course of the training.

"We are trying to wake them up," said Warren about transitioning Marines. "We want them to understand that what we are showing them is very important. The commandant thinks these Marines should all have an opportunity for TAP. It's a gift of time to prepare for the rest of their lives."

Marines honor 65th anniversary of aquatic landing at Guadalcanal

HONIARA, Solomon Islands -- U.S. service members, soldiers from various South Pacific countries, World War II veterans, government officials and Solomon Islanders gathered Aug. 7 to honor the 65th anniversary of the battle of Guadalcanal.

The ceremony was held at the Guadalcanal American Memorial, which overlooks the South-Pacific Ocean as well as the vast jungle terrain where more than 7,000 Americans and 30,000 Japanese lost their lives during WWII.

The Guadalcanal campaign in 1942 was the first major American Pacific campaign in WWII, and the first time the 1st Marine Division conducted combat operations as a division.

"I'm walking on hallowed ground here and I'm honored to have the opportunity to be here today," said Brig. Gen. John A. Toolan Jr, principal director for the Office of the Deputy under Secretary of Defense. "As a United States Marine, you can imagine this is very special to me."

Various government officials from the U.S., Solomon Islands, Australia, New Zealand, Korea, New Guinea and the United Kingdom were also in attendance and laid wreaths at the memorial in remembrance of the fallen warriors.

"We wish to commemorate the unselfish sacrifice of those who brought peace to our shores and let us not forget those who are still serving in other dangerous parts of the world," said Solomon Islands Prime Minister Hon M. Sogavare. "We are forever grateful and determined to

keep their memory alive."

Before World War II, not many people knew about the small island of Guadalcanal near the Australian coast, but after the six-month battle, Americans became very familiar with the events that unfolded here from Aug. 7, 1942, to Feb. 9, 1943, said U.S. Ambassador to the Solomon Islands Leslie Rowe.

Several people in attendance were WWII veterans who served in the day-to-day fighting which took place there. They crossed thousands of miles of the South Pacific Ocean to pay their respects and visit some of the battlefield memorials and reconnect with other veterans.

"I'm more scared here addressing you all than I was out in the bush in 1942," said Owen 'Buz' Miller, U.S. Army veteran who served with the 147th Infantry Regiment. Miller was chosen to speak on behalf of the countless war

veterans who could not make the long trip. "On behalf of all the veterans, I thank you for remembering us all. You have our most profound thanks."

Solomon Island veterans, who served the U.S. and her allies as 'coast watchers' and scouts were also recognized at the memorial. Warriors such as Sgt. Maj. Vouza, who was made an honorary sergeant major by General Vandegrift and who earned both a Marine Corps Legion of Merit medal and a Silver Star medal, were acknowledged for their support against the Japanese in a separate ceremony following the main ceremony.

The memorial observance was attended by the 53-year-old Toolan, who led Regimental Combat Team 1 through Iraq during Operation Iraqi Freedom I and II.

"General Vandegrift said about 45 years ago that the scouts saved Guadalcanal and Guadalcanal saved the Pacific," said Toolan, from Brooklyn, N.Y. "I feel honored to remember those who served here sixty-five years ago."

The day was also an opportunity to honor another fallen warrior at a dedication ceremony later that day.

Because of the many noncommissioned officers in the band and junior Marines in 1/7, Young was in a position with much more responsibility than he had ever been in before.

"I still learn from privates first class and lance corporals because most of them have deployed, and I haven't," said Young.

He was placed in an environment within H&S Company that allowed him to learn everything he needs to know from those above and below him.

"With the right attitude, the senior Marine has the ability to effectively learn and train," said Streater about Young's transition to a different job field.

Young said he felt more comfortable with 1/7 after their Mojave Viper training because he had been given the opportunity to learn his job first hand and develop relationships with the Marines in the company.

"We were surprised by his demeanor and his ability to do so well," said 1st Sgt. Billy Davidson, H&S Company first sergeant, 1/7.

The physical training Young experienced in the band was completely different from 1/7's rigorous PT schedule.

"I discovered that I was not as conditioned as I thought I was during my first PT session with the battalion," said Young.

Young plans to continue pushing himself to ensure he is just as fit as his fellow Marines.

"Sgt. Young is doing extremely well," said Davidson. "He's a very motivated, quick learner."

Young now works directly with the Company H&S first sergeant facilitating and networking within the company.

Once the company is comfortable with Young's progress, he may have the opportunity to be a patrol leader for his company in Iraq.

"Sgt. Young has proven that a Marine is a Marine, regardless of their background or military occupational specialty," said Davidson.

Young decided being a part of this deployment was a major factor that will affect his decision to re-enlist when his current contract ends.

"This is the kind of experience I wish for any Marine, whether it's going from the band to infantry or from a combat unit to a non-combat unit," said Young. "The best way to get the big picture of the Marine Corps is by witnessing all of the different moving parts."

Sgt. Young and the Marines of 1/7 deploy to Iraq in support of Operation Iraqi Freedom at the end of August.







SERE instructor teaches, motivates deploying Marines

Before a unit deploys in support of operations Iraqi Freedom and Enduring Freedom, they must receive a three-hour training session called a high risk and capture brief. What makes these briefs so special is not the training itself but how its taught.

Lt. Col. Chris Ross, Advisor Training Group operations officer, travels from base to base giving deploying units their HRC briefs. However, it's not just the information he presents that keeps the Marine's attention; it's the way he presents it. Ross is a highly motivated, highly animated speaker who brings reality into every presentation, but with his own style of humor and entertainment.

"I try to put as much energy as possible into my instruction because I think Marines deserve the best presentation they can get," said Ross. "I cover a very serious subject, but it doesn't have to be painful to sit through the training. If I have to be animated to emphasize my point, then

that's what I'll do."

Ross said he cannot stress enough how important of a subject this training is to the Marines being deployed to hostile environments.

"A big part of this training is how to resist interrogations, how to avoid giving up tactical information to the enemy and how to avoid being exploited by the enemy for propaganda purposes," he said. "The key piece of the training is preventing isolation on the battlefield and capture to begin with by having good, solid combat actions."

Ross said he has been conducting HRC briefs for the past three years. He has presented nearly 200 briefs to more than 55,000 Marines.

"It's really been a privilege to train these Marines," he said. "They're ready to go into harm's way for us, and the material I cover is some very serious stuff. A lot of times, I'll lose my voice, but at the end of the day that doesn't matter because I know I put my best effort forward for them."

"I put a lot of energy into my briefs and a lot of the guys in the front row get covered in spit and sweat because of it," he added jokingly.

Ross not only provides HRC briefs to deploying Marines, he also doubles as a civilian instructor at the Fleet Aviation Specialized Operational Training Group Atlantic, Brunswick, Maine, where he teaches Survive, Evade, Resist and Escape training.

"I feel that my experience as a SERE instructor has helped me develop my own style for presenting these briefs," said Ross. "I also feel fortunate to work up there because it's about a half-hour drive from my hometown."

The Westbrook, Maine, native stated he joined the Marine Corps for the challenge. He had grown up in a very physical environment, playing football, basketball and baseball for his high school.

After high school, he attended the University of Maine campus in Orono, Maine, where he studied business management. In 1984, he joined the Marine Corps as a reserve infantry officer through the Platoon Leader's Course program.

During his Marine Corps career, Ross said he has been to Iraq several times, which gives him an added apprecia-

tion for the Marines he briefs.

"One of the things that means the most to me is when a young Marine approaches me at the end of a brief and tells me how much he appreciated the training," he said. "I find it very humbling because I have an easy job compared to these guys. When a young lance corporal who's doing all the hard work on the battlefield, I really want to be thanking him. That's my motivation for doing the best job I can to train him for his mission."

Ross will be returning to his duties as a SERE instructor in September where he hopes to continue to support deploying Marines.



A beachside memorial was constructed to honor U.S. Coastguard Petty Officer 1st Class Douglas A. Munro, who posthumously received the Medal of Honor, the nation's highest medal for combat, for his actions during the Guadalcanal campaign.

Several Marines from the Camp Pendleton-based 1st Marine Division and the Hawaii-based Marine Forces Pacific Band made the voyage out to the remote island to provide support and represent the division with the official Marine colors.

"It is an honor for me to be here at this memorial where so many Marines fought viciously and died for their country," said Cpl. Joshua L. Vee, motor transport operator 2nd Battalion, 11th Marine Regiment, who served as a colors bearer for the ceremony. "I don't know any other Marine who has gotten the opportunity to come to this historic place for the Marine Corps. I will remember this for the rest of my life."

The island became a day of remembrance for numerous veterans from many different countries and branches of service who participated in the battle of Guadalcanal.

Every year there is an observance for the anniversary of the Marines landing at Guadalcanal, although the last one of this size and level of support was 15 years ago during the 50th anniversary of the Marines landing here, according to local government officials.

As the Marine Forces Pacific Band played 'Taps' in honor of the countless lives lost in battle, Marines like Vee fought back tears. The ceremony closed with the playing of the Marines' Hymn.

VACCINE TO PREVENT HERPES ZOSTER OUTBREAKS OR SHINGLES

Vaccine to prevent Herpes Zoster outbreaks or Shingles is now available at the base hospital. ZOSTAVAX is a live virus vaccination that is given to patients in order to prevent Herpes Zoster outbreaks (Shingles.) The vaccine can be given to those who are 60 years of age or older if they are TRICARE Prime. The vaccine should not be given to anyone who has had a significant allergic reaction to gelatin or neomycin. These reactions would include hives, difficulty breathing, or swelling of tongue/lips/throat. Also the vaccine should not be given to anyone who is pregnant, of child bearing age, or immunosuppressed. Please talk to your doctor if you think this vaccination may be beneficial for you.

REGISTER YOUR WEAPONS. IT'S EASY!!!

According to CCO P1630.6E, chapter 4, all weapons introduced to the Combat Center must be registered with the Provost Marshal's Office and conform to all California regulations for transport. Weapons can be registered at the Vehicle Registration

Office located at the front gate Building 901. Personnel do not need to bring their weapon to the front gate, only the serial number. Rifles, shot-guns, pistols, bows, bb/pellet guns, paintball guns, air soft guns, swords, spears, and knives with a blade more than 4 inches are all considered weapons and must be registered. Gen. Pace applauds all-volunteer force

DJIBOUTI – The all-volunteer force is serving the United States extremely well, the chairman of the Joint Chiefs of Staff told service members at a Town Hall meeting here today.

Gen. Peter Pace spoke of the difference between the conscripted force of his youth and the all-volunteer of today.

When Pace first came in to the Marine Corps in 1967, it was a draftee military, and there were many people serving in the military who didn't want to be there.

Pace said in the conscript military leaders had to spend time motivating people to do the right thing. This is not a problem confronted by commanders with an all-volunteer force, Pace said.

"This is because you have in your heart of hearts the basic knowledge that you volunteered to do this and because you wanted to be there," Pace

told the troops.

"Everybody here either volunteered to serve their initial tour or re-upped while the nation was at war and wanted to do their part," Pace said. "God bless you for that. That motivation factor allows you to have teamwork and train to heights that you could not if you just fundamentally had people who didn't want to be there."

Pace said he thinks that everyone should serve the nation.

"I think it would be good if everyone served the nation in some capacity," he said. "Through an accident of birth we are American citizens. We grew up in an incredible nation that allows us to be literally anything we want. To pay back the opportunity is a price that is worth the nation considering."

Pace said he is not talking about military conscription, "but an opportunity for all young folks to pick from a variety of things to give back to the nation that has given them so much."

With the ball firmly in the crook of his arm Maggitc sprinted through 3/4's offense into their end zone to score 1st Tanks' second touchdown.

The touchdown caused a switch of teams, bringing Miramar out on the field one last time to play against 3/4.

The final plays proved to be strenuous as both teams were exhausted. Neither team moved the ball down the field, bringing the
