## SMMC: 'Baby NCOs' story an insult to junior Marines

HEADQUARTERS MARINE CORPS - "I am an NCO dedicated to training new Marines and influencing the old. I am forever conscious of each Marine under my charge, and by example will inspire him to the highest standards possible. I will strive to be patient, understanding, just, and firm. I will commend the deserving and encourage the wayward.

I will never forget that I am responsible to my Commanding Officer for the morale, discipline, and efficiency of my men. Their performance will reflect an image

I can remember the day I got promoted to NCO like it was yesterday. Pinning on that extra stripe didn't just mean extra pay or privileges, it meant I'd achieved a rank that is not taken lightly and is highly respected by all throughout the Marine Corps. That promotion will always be one of the proudest moments in my career.

I have no doubt that getting promoted to NCO is as momentous an occasion for junior Marines nowadays as it was for me back when I got promoted. It was for that reason alone that I felt just as insulted as all of the NCOs around the Corps when I read the "Baby NCOs" story in the Marine Corps Times a couple months ago.

Regardless of the story subject, there will never be a time and a place that the words "baby NCO" could be used to accurately describe junior Marines - never!

Getting promoted to any rank in the Marine Corps is an accomplishment and to insinuate that the Corps' new batch of NCOs is going to be any less deserving than their predecessors is absurd. If anything, Marines of this day and age are just as combat hardened and have as great a responsibility as their predecessors.

Undeniably the Marine Corps Times supported its story with a memo from the Center for Naval Analyses, but even the analysis didn't show the reader the complete Marine.

About half of the Marine Corps is made up of Marines in the ranks of private through corporal; nearly 70,000 Marines are ages 21 and below. It's these young, junior Marines - through the mentorship of the Corps' great staff noncommissioned officers - who will be carving out the future of the Marine Corps for all to follow.

As the senior enlisted Marine in the Corps, I have witnessed the great things the Corps' small-unit leaders are doing both on and off the battlefield.

I have seen Marine NCOs serving in combat in billets one, two, even three ranks higher than their rank dictates - and in some cases, officer billets. I've wit-

enough to vote and definitely not old enough to drink, make splitsecond decisions on the battlefield that saved the lives of many of their fellow Marines.

I've read countless award summaries describing heroic acts by Marines wearing the very rank the Marine Corps Times insulted.

I've seen severely wounded Marines more concerned with not letting their fellow Marines down by leaving the battlefield, than they were with receiving lifesaving medical treatment. I've visited numerous hospitals where Marine NCOs struggled to rehabilitate themselves in order to simply walk 10 feet after surviving an IED blast in Iraq.


And sadly enough, I've said a silent prayer for the more than 300 Marine NCOs who have their lives given during Operations Iraqi/Enduring Freedom.

I'm confident that in five, 10 or 15 years, it will be Medal of never let the Corps down.

nessed junior Marines barely old Honor recipient Cpl. Jason Dunham or the more than 30 junior Marines who have received either the Navy Cross or Silver Star who will grace the pages of Marine Corps history books. These are the kinds of Marines that are going to be filling the future ranks of the Marine Corps, regardless of what some reporter wants to imply.

> So when I read a story that mentions anything but praise for the thousands of Marine NCOs around the globe, I feel it is my duty to speak out - it is the right thing to do. I will never sit idle and let anyone speak negatively about the Marines serving in the Corps.

The Corps is extremely proud of the Marines serving today and I'm especially proud of the junior Marines who, as I once did, strive to achieve the rank of NCO - one of the best ranks in the Marine Corps. I trust that when promoted, each new NCO will take the NCO Creed to heart and will

-First Sgt. Manuel Colon, Alpha Company first sergeant, 3rd Combat Engineer Battalion "I think the sergeant major is right on point. Our 'baby NCOs' are dealing with challenges that prior Marine NCOs have faced in the past and are operating just as effectively, if not, more so. When I was in Fallujah with 3/5, I saw young Marine corporals, even lance corporals, execute their duties flawlessly. I can walk down the street and run into a corporal with a Navy Cross or a sergeant with a Silver Star. Go ahead and try to tell me those Marines are babies. They are grown

"Sgt. Maj. Kent is absolutely right. Marine NCOs are out there doing some amazing things. Whatever this article wants to say about NCOs being 'babies' is absolutely garbage. It's all about young Marines stepping up to the plate, taking on a lot of responsibility and doing a fantastic job. Even here, I have five NCOs, all under the age of 24, each in charge of their own section; an armory of more than 200 weapons, a warehouse with half-a-million dollars worth of equipment, a budget of more than \$200,000, the administration of more than 500 personnel annually and accountability of thousands of rounds of ammunition. When I was growing up as a young NCO, we didn't get nearly as much responsibility as NCOs are getting now."

## **Bush signs fiscal 2008 Defense budget**

WASHINGTON, Jan. 28, 2008 -President Bush signed the longdelayed and sometimes-contentious fiscal 2008 National Defense Authorization Act into law today.

The Senate passed a \$696 billion 2008 defense authorization bill Jan. 22. It includes a 3.5 percent military pay raise and provisions to improve health care and benefits for wounded troops and veterans.

"Today, I have signed into law H.R. 4986, the National Defense Authorization Act for Fiscal Year 2008," Bush said in a statement released by the White House. "The act authorizes funding for the defense of the United States and its interests abroad, for military construction, and for national security-related energy programs."

The fiscal 2008 defense budget has been laden with challenges, from Congress' inclusion of nondefense-related earmarks to its insertion of controversial language regarding Iraq. Bush announced Dec. 28 that he wouldn't sign the bill until it was revised.

Instead, the president signed an executive order authorizing a 3 percent military pay raise. The amount was 0.5 percent lower than the 3.5 percent rate provided for in the authorization act, but took effect Jan. 1.

All pays and incentives included in the authorization act will be retroactive to Jan. 1, a defense official said.

White House Press Secretary Dana Perino told reporters today Bush was gratified that Congress moved forward with the budget bill.

"He appreciates the cooperation of both House and Senate leaders to quickly address the concerns raised by the president over the Christmas holiday," she said at the White House. "Congress passed the legislation swiftly, and that is a very good thing for our troops and the Iraqi people."

The bill became law just a week before the next budget cycle begins as Bush sends his fiscal 2009 request to Capitol Hill. That budget proposal, along with a requested \$70 billion in emergency war spending, is expected to be delivered to Congress Feb. 4.

Pentagon spokesman Bryan Whitman told reporters today the president plans to ask for \$70 billion to fund the global war on terror, including operations in Iraq and Afghanistan, for the first months of fiscal 2009.

## Veteran firefighter promoted for performance, dedication

Hard work, skill, professionalism, dedication and love for the job are traits the entire Combat Center Fire Department displays daily, willing to risk life and limb to keep the personnel aboard the installation safe.

Dan Stanifer, Center Fire lieutenant, was promoted to his current rank Jan. 19 for his exemplary performance in all aspects of his profession.

Born Dec. 14, 1961, in Ridgecrest, Calif., Stanifer was raised near China Lake Weapons Research Facility. He said he grew up as an outdoorsman; fishing, hunting, shooting and practicing archery.

In 1980, he graduated from Apple Valley High School in Apple Valley, Calif. From there, he began finished carpentry work and held other odd jobs while continuing his education. Stanifer studied fire technology and criminal justice at Victor Valley College and Barstow Community College.

Although Stanifer said he had never considered being a career firefighter while he was going through school, he decided to look into the possibility.

"A friend of mine from high school called me up one day and told me he was going to the fire department to check it out," said Stanifer. "At the time, I was looking at a career in law enforcement, but I thought it'd be a hoot, so I went with him. I loved it from the very beginning. It's where my heart took me."

Stanifer, a 22-year veteran of the fire service, began his firefighting career in 1985 when he took a job with the Bureau of Land Management in Apple Valley as a seasonal wildland firefighter. During this time, he also

"We get reservations from family birthday parties to command meetings," said Gonzalez. "As long as one service member in the meeting lives in housing they can reserve it."

The community center has been reserved for military unit functions as well, such as unit family days, holiday gatherings and sporting events.

The community center is a

popular place for parents wanting to utilize the workout room while their children are inside the Xbox 360<sup>™</sup> room, where multiple Xbox 360's<sup>™</sup> line the room hooked up to individual flat screen TV's with lounge chairs for the gamers.

Military spouses and families have used the community center to hold Operation Enduring Families or Key Volunteer Network gatherings where children make posters and signs to be

sent to their fathers that are currently deployed.

Ocotillo Community Center is in building 4000 on Falcon Street, Desert View Club House is in building 6900 on Smoketree Avenue and Adobe Flats Club House is in building 8100 on Maumee St.

## Fit 4 Kids program teaches children about exercise, nutrition

The Marine Corps Community Services Semper Fit offers a program called the Fit 4 Kids every Tuesday, Wednesday and Thursday that educates children about the benefits of eating healthy foods and exercising regularly.

The program began Jan. 22 and is an eight-week course that is split into three classes to accommodate different age groups.

Children ages 3 to 5 meet every Tuesday, children ages 6 to 8 meet every Wednesday, and children ages 9 to 12 meet every Thursday.

"When the program ran during the summer, all the age groups were lumped together," explained Amber Moschetto, mother of 5-year-old Kaitlyn Moschetto who attends the class. "The little kids lost a lot of the games, but now that the ages are split up they all have a chance to win and have fun."

The class runs from 3:30 p.m. to 4:30 p.m. where Shenette Slaughter, MCCS personal trainer and recreation specialist, keeps up to 20 children active by playing games and teaching classes about nutritional foods and keeping the body healthy by regular exercise.

"Last week I handed out a My Pyramid for Kids," said Slaughter. "We went over what fruits and vegetables are and why they are good for your body."

Slaughter also reviews different types of drinks with the children, explaining to them what is healthy and what is bad for their body.

"It is great," said Moschetto.
"Someone else saying fruits and vegetables are good for her and my daughter actually lis-

"She says she wants carrots for her eyes, milk for her bones and corn for her hair," continued Moschetto.

The children are given homework once a week where they may have to fill out a chart of all the fruits and vegetables they have eaten for the past week, or come in to the class and describe a brand new vegetable they have eaten.

"At this age they come home and don't stop talking about what they did that day," said Kelly Yarbrough, mother of 4-year-old Luke Yarbrough who attends the class. "So after this class he comes in and won't stop talking about the fruits and vegetables they have to eat for homework. When I was a kid we never had this, it is a good thing for him because they'll all grow up healthy."

The children play different types of games that help enhance their motor and cognitive skills.

"We dance a lot," said Luke

Yarbrough. "My teacher keeps us moving."

Some of those games are musical hoops, zoo animals or just walking around the gym balancing a beanbag on different parts of their body starting at their head and ending on their toes.

"I always tell parents that they can leave the gym area and go get a work out for an hour in the community center, that way both the parent and the child get a full work out and the parent doesn't have to worry about where their child is," said Slaughter.

about him coming out. It brings more attention to Twentynine Palms and this area and more riders and more people want to join [MSAP]."

The Marines and stunt riders drove from the Combat Center through Joshua Tree National Park, Calif., and stopped at the Keys View Lookout and other various places throughout the National Park. After the ride, the motorcyclists stopped at Denny's® for dinner.

"I thought the ride was pretty incredible," said Britton. "We started out from the base rode up through the mountains and ended up at this incredible lookout.

MSAP, during the first year of running had five active participants. Now over 60 riders show up for monthly meetings and safety rides throughout the surrounding areas around the Combat Center.



allows Marine Corps combat elements to stay a step ahead of the enemy threat and makes them more prepared for combat.'

MCTOG is intended to focus training on the battalion and regi-

ment levels of unit structure, as opposed to schools that train at the company level and below. Since MCTOG is a newly-developed program, Robison also added ideas to help the program stand up effectively.

"When working with all coali-

The DVTE also has a virtual language training program that teaches Marines how to properly speak and understand Iraqi Arabic, Pashto, Persian Dari and Creole French.


Robison seemed to find the training programs he viewed Jan. 24 and 25 both fascinating and advanced.






