

Darkside welcomes new commander

Lt. Col. Martin F. Wetterauer relieved Lt. Col. William A. Visted as commanding officer of 3rd Battalion, 4th Marine Regiment, during a change-of-command ceremony at the Combat Center's Lance Cpl. Torrey L. Gray Field Nov. 20.

Visted, a native of Pearl City, Hawaii, assumed command in September 2007 and is moving on to 7th Marine Regiment, where he will serve as the regiment's executive officer.

Wetterauer takes command after serving as 7th Marine Regiment's operations officer since April.

Once the passage of command had taken place, Vincent addressed the audience and admitted it was going to be hard to leave the Marines and sailors of the battalion behind.

"It's been a long day coming and one I haven't been looking forward to," said Visted.

"Leading this organization we call the Darkside has been a tremendous experience."

Visted then thanked the Marines, sailors, and civilian personnel of the Combat Center, and after talking about the accomplishments of the Marines and sailors of 3/4, which included a recent deployment to Al Anbar Province in support of Operation Iraqi Freedom, he asked for all those in attendance to give the battalion's warfighters a round of applause.

Once the applause ceased, Visted told those in attendance he was truly blessed with a superb command team, which included his senior enlisted advisor, Sgt. Maj. James D. Walsh; his executive officer, Maj. Kevin A. Norton; and his wife, Sheri.

Before handing over the microphone to his successor, Visted wished Wetterauer the best of luck and told him commanding 3/4 would be the best time of his career, before addressing the

23rd Dental trains for new environment

The Combat Center's 23rd Dental Company completed a dental field equipment test Nov. 17-21 behind the Adult Medical Care Clinic.

The goal was not only to test the new dental systems, but also to train the sailors how to treat patients in a mobile operational environment.

"Navy dentistry has a long-standing tradition of delivering quality service in the field to forward deployed Marines and

sailors," said Cmdr. Kurt J. Brockman, the 23rd Dental Company commander. "As we shift our Global War on Terrorism focus to Afghanistan, 23rd Dental will need to be ready to serve in that country."

"In order to do this, the brick and mortar facilities utilized in Iraq will need to be replaced with tents," added the Newport Beach, Calif., native. "Dental units will need to be mobile and dental services will need to be delivered

New Heritage Memorial Park gives glimpse of MCAGCC's past

Heritage Memorial Park, located between Del Valle road and Victory Field, opened Monday with a ribbon cutting ceremony and a glimpse back into time to view the Combat Center's history.

After the invocation, Brig.

Bob Lehman, the chief engineer and architect with Public Works Division, also spoke regarding the building of the memorial and the rest of the

Boatspaces 'sailing off' quickly

MARINE CORPS BASE CAMP PENDLETON, Calif. – First-term Marines approaching their End of Active Service in fiscal 2009, must speak with their career planner as soon as possible because of changes in fiscal 2008 and 2009 re-enlistment options.

Master Sgt. Patrick E. Whitaker, career planner, Marine Corps Installations West, explained why Marines EAS'ing this year must act quickly.

What changes can first-term Marines expect? In fiscal 2009, the Marine Corps is bringing back what is known as "boatspaces." Boatspaces limit the number of Marines who can re-enlist in each Military Occupational Specialty, as determined by Headquarters Marine Corps.

How does that affect me? The Marine Corps has accomplished more than 60 percent of their re-enlistment goal for first-term Marines, which means boatspaces are filling fast. Once an MOS reaches its quota on boatspaces, the MOS is closed out and a bonus for that job field is no longer offered.

What if my MOS is closed out? If a Marine's MOS is closed out, that Marine will need to decide whether to EAS from the Marine Corps or lateral move into a new MOS.

Could I still get a bonus if I lateral move? Marine Administrative Message 370/08 establishes which MOS's rate a bonus and how much they are worth. Marines who lateral move into a new job field will receive the bonus once they finish the training at their new MOS school.

What if I'm unsure about re-enlisting? If you are unsure about re-enlisting in the active-duty force, the best thing to do is to go to a career planner and submit the re-enlistment package. At that point, you will have 10 days before you must re-enlist and take the oath. What other benefits are there for re-enlisting? The Marine Corps wants to retain first-term Marines because they have the experience and skills of a Marine instilled in them. Besides receiving a possible bonus, Marines who re-enlist are guaranteed a preferred duty station, earn 60 promotion points if they are a lance corporal or corporal, continue receiving medical and dental benefits, leave and job security by re-enlisting.

What if I EAS and decide to come back in later? If a Marine separates, they must speak with a prior service recruiter. They will have no guaranteed duty station and may be unable to retain the same MOS. If a bonus is offered in the MOS they re-enlist to, the full bonus will be given within 90 days of their EAS date; 80 percent is given between 91 and 365 days; and 60 percent between 366 days and four years. Bonuses are not offered if they wait longer than four years.

Do boatspaces affect Marines who are not in their first-term? No, boatspaces only affect Marines in their first-term. Once a Marine is on their second term, they are considered a "career Marine." Boatspaces do not affect their re-enlistment options, including MOS and bonuses.

What if my EAS is not until later in the year? The Marine Corps has reached more than 60 percent of its re-enlistment goal and boatspaces are on a first come, first serve basis. If a Marine waits until August 2009 to re-enlist, there is no guarantee they will receive a bonus or continue in their current MOS.



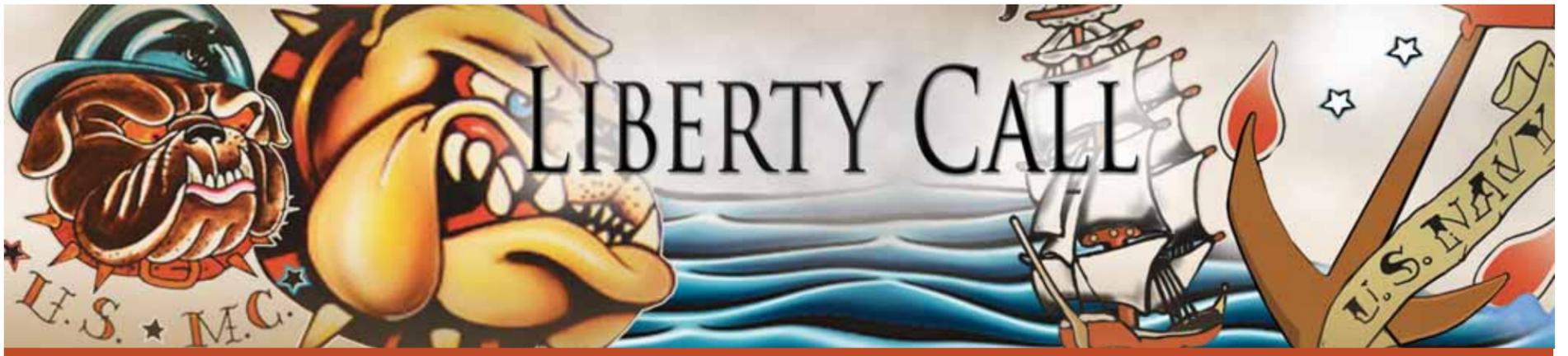

A few helpful tips to get you home for the holidays

As the holidays draw closer, Combat Center Marines, sailors and their families are beginning to make their travel plans to visit their friends and family throughout the world.

Whether the path to visit friends or family is on the ground or in the air, it is beneficial to plan and practice safety precautions to ensure a safe and timely arrival for the holidays.

If driving home, don't get sidetracked by thinking of home-cooked meals and heaps of presents. Instead, make sure the vehicle making the trip is in good working condition.

Double check engine fluids, including windshield wiper fluid, and make sure tires are properly filled with air. While packing the vehicle, ensure the rearview window is clear of all luggage and pack an extra blanket, flashlight, food and first aid kit in case of a roadside emergency.

David Horn, the Combat Center's security director, says the number one risk while driving long distances is fatigue.

Getting a healthy amount of sleep the night before the trip will help keep drivers alert of their surroundings, said Horn. Waking up early enough grants enough time to get to their destination on time without the rush. Big meals are also cautioned against since

they may cause drowsiness.

"Fatigue is an impairment like drugs or alcohol," he continued. "Stop driving and either find a place to sleep for the night, or find a safe place to take a 15 to 20 minute nap."

Safe driving habits should also be implemented, which include wearing safety belts, maintaining a safe distance between vehicles, using proper turn signals, and not

drinking and driving.

Before travelling, people should prepare their homes to help prevent break-ins or emergencies. Staff Sgt. Anthony Fox, the Provost Marshal's Office physical security chief, advises home owners to stop mail and newspaper deliveries or have a neighbor collect them daily.

Leaving shades in a normal position, and putting a radio and

at least two lights on an automatic timer, will make a house look like it is being occupied, which will dissuade burglars. Have a neighbor place trashcans at the curb of the unoccupied house, and park a car in the driveway occasionally.

"Ask your police department if it has a 'vacation check' program," said Fox. "You should indicate the dates of your departure and return, as well as

PMO, MUSD help keep kids off drugs

The Combat Center's Provost Marshal's Office has partnered with the Morongo Unified School District to educate fifth-graders on the dangers of alcohol, tobacco and drug abuse.

Throughout the school year, representatives from PMO's Physical Security and Crime Prevention Branch are visiting 11 elementary schools as part of the Drug Abuse Resistance Education program, which has been running since 1983.

"We're here to teach about alcohol, drug and tobacco facts instead of the misconceptions about those substances," said Dana Fisher, a PMO D.A.R.E. officer. "We also teach them how to be better kids and make the

right choices.

"Hopefully the kids will keep these skills for the rest of their lives," added the Oakland, Calif., native. "Our primary goal is to teach them a positive attitude. Keeping a positive attitude is half the battle."

Before the 10-week program begins, all the children are asked to sign a student participation letter, said Carey McElroy, a PMO D.A.R.E. officer. The letter ensures the children know what they will be learning and what is expected of them throughout the course.

In order to graduate, the students must complete all their work, have good attendance, demonstrate good behavior, stay free of drugs, write a D.A.R.E. report, and pledge to make good decisions about alcohol, tobacco and drugs, added the Delta, Ohio, native. Failure to complete any of



Wall recognizes active duty service members

On the other side of Joshua Tree National Park, in Chiriaco Summit, Calif., the General Patton Memorial Museum does more than honor the three-star

general and his beloved Army.

The museum, which is located just off Exit 173 on Interstate 10, has erected the Defenders of Freedom Wall, which is the museum's way of showing respect for the men and women who are fighting for this country's freedom, said Jacque Schindewolf, the museum's conservator.

"The Defenders of Freedom Wall is a tribute to all that protect this country," said Schindewolf, a native of Ely, Minn. "This wall is a way of saying thank you; we honor what you do for us."

Schindewolf said any service member who has served since September 11, 2001, to present day can have their name placed on the wall. Border patrol officials, customs workers, police officers, sheriffs, and firemen are also eligible to have their name placed on the wall.

"Our goal is to honor all who keep us safe and protect our freedoms," said Schindewolf.

In order to have a named placed on the wall the museum requests the honoree's name and service, a \$10 check or money order, and while proof of service is not required the museum does recommend it.

Once the process is complete, the name of the honored service member will be engraved in black lettering on one of the granite plaques mounted on the wall's cement frame.

Liz Kepner, a museum staff member, said she thinks the wall is great way to honor those service members who are currently serving this country.

"I think it's great," said Kepner, a native of Desert Center, Calif. "I think it's fantastic that people can come by and see their names on the wall."

Kepner said it is an honor to recognize those who are currently serving this country and that it has been a joy to see the facial expressions of the people whose names are on the wall when they see it for themselves.

While Kepner has no family

NRA opens fire at the Combat Center's rifle range

The National Rifle Association hosted their 49th annual Twentynine Palms Long Range Regional at the Combat Center's Marksmanship Training Unit from Nov. 20 to Sunday.

The matches this year were

open to not only NRA members and service members, but also to anyone who wished to participate, said Jack Edmonson an NRA member and a native of Bethany, Conn.

Edmonson added changes have been made to the tournament itself this year.

"This year of course changes

ranging from participant eligibility to weapons used have been instituted," Edmonson said. "Those not in the NRA can now compete and we are now allowing the use of Palma rifles for the first time. Palma rifles are those of a .308 caliber, and are in their own class of competition. Also the use of bipods has been instituted.

Although their use is allowed they have slightly smaller targets for those using a bipod, and all weapons must be registered with any attachments and round sizes before competition."

Edmonson said paid target pullers were available on Nov. 19 for hire so shooters could have a day of practice at the 1,000-yard line before the competition began.

The next three days to follow were filled with expert civilian shooters and service members sending rounds down range, said Edmonson.

"Shooters have individual competition and team competitions to compete in," he said. "Shooters will be shooting long range, rapid fire and slow fire, ranging from The 200-yard line shooting up to 1,000 yards."

Experienced shooters at the Combat Center, such as Rich Vedvick, an NRA member from Concrete, Wash., who has competed 14 times in the competition still comes because he says he is an enthusiast and loves competition shooting.

"I've been at this competition every year since 1994 with the exception of 2001," said Vedvick, during the competition Saturday. "I won three of the 1,000-yard matches Thursday and Friday, but I'm not shooting as well today. I love coming down to Twentynine Palms for this,

because of the blue sky and sunshine you get out here. It's a great place to shoot and the weather is much better than where I am coming from."

Shooters at the competition included regular members of the NRA along with notably famous former service members who enjoy shooting as a hobby.

Retired Gunnery Sgt. R. Lee Ermey, the host of the new History Channel show *Lock and Load*, also participated in the events with his partner Dennis Demille, who competes with Ermey to make the *Hornety Over the Hill Team*.

"Me and Dennis shoot together. He's a friend of mine and a two-time national champion," Ermey said. "This is the first time I've been to Twentynine Palms to fire on the range. I've been here countless times for other things, but this is one of the nicest ranges I have ever fired on."

Ermey said even though it is his first time shooting his rifle here, he really has enjoyed his experience at the Combat Center's range, which included having a watermelon on a stick put in place of a target for him to shoot.

"I love to shoot just like any of the other competitors out here," he said. "It's a beautiful range and a fun competition, with what little wind there is right now its been a great time for us."

"We started doing actual fight competitions about six years ago," said Fowler. "These are considered pre-armature tournaments."

The second competition this month, Grapplers Extreme tournament, hosted Saturday by Fight Lab in Marietta, Calif., allowed the Fight Club 29 team to crank up the competitive spirit and dominate the tournament as the first place team. Every member earned a medal — three gold, one silver and one bronze.

medalists, fought in a tournament with the team for the first time that day. Wolf, who claims folk wrestling as his original fighting style, weighs in at more than 220 pounds and dominated every one of his opponents with powerful body strikes, quick counter movements and solid ground technique.

Wolf attributed his success on the mat to the training and conditioning he underwent with fellow teammates under the supervision of Fight Club 29 head coach, Mark M. Geletko.

"I was a little nervous before hand, but I think I was more anxious than actually nervous," said Wolf about his first fight. "I did really well by the third fight because my nerves went away."

Wolf added he believes after continuing his conditioning and training, he will be faster and stronger by his next tournament.

Geletko said he looks forward to honing the fighters' skills even further in anticipation of the next tournament.

"I was really pleased with how

we did, especially this being the first Pankration tournament for a majority of our fighters," said Geletko, a Pittsburgh, native. "I think our conditioning really kicked in at the end of the fights. That's what gives us our edge. We usually win in the final minutes because we have more gas."

Geletko said as the fight club looks toward a month-long break, it will offer the team an opportunity to bring on more members and train them for tournaments beginning January 10.

Marine demonstrates bravery during Afghan deployment

With its rocky desolate mountainous terrain surrounding the southern stretches of the Nangarhar province, the Pachir Wa Agam District, already a hornet's nest of battle hardened insurgent fighters, was the setting of a deliberate and violent ambush. An Afghan Border Police Motorized Combat Patrol with Afghan National Army Embedded Training Team 2-5 personnel took direct and indirect fire from a 450-man anti-coalition militia element.

Lt. Col. Christopher Nash, currently the operations officer for Advisor Training Group aboard the Combat Center, was the officer-in-charge of ETT 2-5 while deployed in the Pachir Wa Agam District.

On June 21, 2007, Nash and an Afghan Border Police Motorized Combat Patrol with ETT 2-5 embedded personnel were ambushed and severely outnumbered.

With Afghan forces in disarray, Nash took control of the situation. He immediately took cover and engaged the enemy as the remainder of the combined patrol followed his lead. Even when incredibly outnumbered with only eight U.S. personnel left in the fight, Nash chose to stand and fight.

As the engagement progressed, Nash moved to a position that better facilitated communication and repeatedly exposed himself to direct and indirect fire when moving from position to position.

Hours into the fight, Nash made the decision to retrograde out of the area after he was informed that aviation fires would not be provided and the Coalition Quick Reaction Force had been ordered not to proceed south of the Pachir Wa Agam District Center.

Before doing so, he directed and assisted with the recovery of Afghan remains. When a wounded Afghan soldier was located, Nash personally assisted the movement of the soldier to the vehicles while under sporadic fire.

The team proceeded to the vicinity of Pachir Wa Agam District where it linked up with

the Coalition Quick Reaction Force. Shortly after arriving, Nash received a call from the governor of Nangarhar stating that the road north of Pachir Wa Agam had been cut off by a force of over 70 anti-coalition militia and that the Quick Reaction Force would be sent in to try to open the road.

Nash was then asked to organize a defense to hold the Pachir Wa Agam District Center until additional forces arrived. He also directed a detachment of his own team to support a vehicle recovery mission from the confrontation earlier.

As a direct result of his expertise and initiative, the District Center was held throughout the night and all vehicles were recovered by morning.

At a ceremony at Range 220A, Nash was awarded a Meritorious Service Medal for his time with ETT 2-5 and a Bronze Star with combat distinguishing device for his actions in Afghanistan.

After the citation was read and Nash received his award, he spoke to the Marines, contractors, role players and family members in attendance.

"My real award was bringing all my Marines and sailors home," Nash said. "Day in and day out, with minimal to no support from coalition forces, they would head out into the enemy influenced and controlled border areas with our brothers the Afghan Border Police and the Afghan National Army daily and try to bring positive change in the lives of not only the Afghan security forces but the Afghan population."

Nash explained how the mission is about what can be done for the Afghans. They liked the U.S. forces there because they fought side-by-side and gave hope when they had little.

Nash credits his family for get-

ting him through the deployment. He believes that the love he has for his family is the reason why he and his Marines are alive today.

"Outnumbered 50 to one, Afghan and U.S. forces refusing to enter the valley, and no aviation or indirect fire, I knew in all likelihood we were dead men," Nash said. "In that moment in my life I saw my wife and children. In this moment of clarity, it allowed me to see the field for what it was and not what I wanted it to be."

Nash not only has support and respect from his family, but also from his Marines. His battle tested ability to maintain discipline in the face of such adversity is a credit to all who know him.

"When Lt. Col. Nash speaks with Marines he speaks with them, not to them, unless, of course, they have done something to deserve to be spoken to and not with," said Col. Eugene Apicella, the director for Advisor Training Group. "He has an ability to listen to others and values their perspectives."

Not only is Nash said to be recognized for his ability to lead, but also as being one of the leading experts by his peers in the Advisor Training Group.

"He is one of the few that not only understands the importance of the advisor mission and how it should be done, but he is also able

to share that knowledge and insight with others in a format that is understandable to junior and senior Marines," said Lt. Col. Richard Warmbold, the deputy director for Advisor Training Group.

Although Nash has since returned from Afghanistan, he

still holds close to him the experiences and hardships he met on his deployment and on that difficult day of combat.

"I take less for granted," Nash said. "I value every moment I have with my wife and children and the opportunity to serve with Marines."

which rooms have timed lights and which neighbor has a key.”
If the journey home involves airfares and hotels, make sure to book flights and reservations as early as possible to save time and money.

Flights should be booked two to three weeks prior to departure for best possible fares, said Jonid

Castillo, a traveler counselor with traveler and transaction services, Military and Government Markets CWT-SatoTravel. The best days to travel are Tuesdays, Wednesdays and Saturdays.

Travellers should also get to the airport at least one hour before take off since most flights will cut off checked baggage 45 minutes before take off. Checking in two hours

before departure is recommended in case of long lines.

People should research ahead of time what they can and cannot bring. The Transportation Security Administration Web site, <http://www.tsa.com>, has many good tips on travelling.

TSA has a 3-1-1 rule, which allows three-ounce bottles of liquid or less, and one, one quart plastic ziplock bag per customer

to carry on the plane. The ziplock bag must be available for screening at a checkpoint.

“To avoid extra security screening, have all loose items such as jewelry, keys and wallets in a carry-on bag to process,” said Castillo. “Be aware of weather conditions, not only at the final destination, but also at connecting stops; therefore if possible avoid flights that go through cities

that normally have bad weather.”
When collecting baggage, it is important to check for missing items because you don’t want to get home to file a claim with the airline.

By planning properly and traveling smartly, the holiday season can be inexpensive, timely and safe for everybody trying to get home to spend time with their loved ones.

The Economic Health Of Our City Is Important!

Where DO your local tax dollars go?

SALES TAX on normal purchases, excluding groceries, is 7 3/4 percent, a portion of which goes back to the city where the purchase was made. Every time you buy \$100 worth of non-grocery items in Twentynine Palms, the city gets \$1. In the current fiscal year, the city of Twentynine Palms is looking to get \$702,000 in general funds from sales-tax revenue.



EVERY TIME you spend a dollar anywhere in San Bernardino County, a half-cent of your sales tax goes into the Measure I fund, which is then redistributed to cities, like Twentynine Palms, based on population. Measure I funds are used to pay for transportation-related expenses, including improvements to existing road.



PROPERTY TAXES are a major source of General Fund revenue for Twentynine Palms and help pay to maintain city parks, such as the newly-dedicated Bucky Bucklin Park. For every dollar you pay in property taxes for property it the city limits 26 cents comes back to the city. In the current fiscal year, this will add \$1,350,000 to the city's General Fund coffers.



PURCHASE GASOLINE anywhere in the state and a portion of the sale is a gasoline tax, which goes to Sacramento before it's redistributed back to cities based on population. During the 2007-08 fiscal year, the city received \$492,775

in remote areas. What has become established will need to be expeditionary.”

The equipment was tested in a field tent, which was modified to accommodate an examination chair, a hygiene chair, a general dentistry chair, and a specialty chair used primarily for oral surgery.

Petty Officer 1st Class Jerry Hughes, a 23rd Dental biomedical equipment repair technician, said approximately 30 people from the clinic were either rotated out to the test site, or were working there during the whole week.

Throughout the test cycle,

more than 80 patients were seen at the site, and were given the same quality care delivered in the clinic, but also experienced dental service in a field environment.

The testing of the new equipment is being evaluated by Marine Corps Systems Command and the Air Force Medical Evaluation Support Activity. The Combat Center was their second test site after the groups visited Marine Corps Base Camp Lejeune, N.C.

Air Force Lt. Col. Michael W. Henry, the AFMESA director of aeromedical evaluation programs, said the tests will focus on a variety of areas, including how the equipment works in different

environments, temperatures and other forms of weather.

If purchased, the new equipment will replace the Dental Field Treatment and Operational System, which is currently being used Navy- and Marine Corps-wide, said Randy Shanholts, the Marine Corps Systems Command test lead.

Despite the ambiguous results of the testing, sailors at the dental clinic were happy to have received the training.

“I think the testing went really well, and we got a lot of information from it,” said Hughes. “Not only did we get a chance to do some testing that will have an impact on Navy field dentistry, but it was also a good opportunity for our sailors to train in a field

environment. It was a very successful training evolution.

“It was an excellent opportunity for us and I think any one of the sailors here would do it again if we could,” added the Azle, Texas, native. “We got excellent support from Headquarters Battalion and CLB-7 [Combat Logistics Battalion 7], and even got logistical support from the regimental aid station. To give credit where credit is due, we couldn’t have done it without those guys.”

Brockman said he thinks the testing is beneficial to his sailors and the field of Navy dentistry.

“The 23rd Dental Company evaluated new field dental equipment designed to deliver quality service in the field to forward deployed Marines and

sailors,” he said. “We also had the opportunity to educate the next generation of dental officers and hospital corpsmen on field dental delivery.”

Although most of the testing has been completed, it has yet to be determined if the new dental equipment will be purchased by the Navy or the Marine Corps. If the equipment is bought, it also hasn’t been said when it will be put into circulation for use.

Coyotes: The bigger our footprint, the bigger the problem

Despite increased efforts to help quell the number of coyote sightings in the Combat Center's housing areas, the base is still experiencing an increase in activity, which may pose a threat if not handled properly.

The Natural Resources and Environmental Affairs Division has been taking action through their catch-and-release program since Aug. 1 by trapping coyotes and letting them go in the Sand Hill training area several miles west of Camp Wilson.

"Part of the problem we have is that we all realize this is a problem that will never completely go away, but we can minimize it," said Dr. Brian Henen, an NREA ecologist. "We're never going to get rid of the coyotes, but we can get rid of what draws them in - it just requires participation from everybody on base."

Henen, a Vista, Calif., native, said the biggest problem is people leaving food, water and trash laying around where coyotes and other wildlife can get to it with ease.

"We're in a constant battle with people leaving their trash bins open, or having loose trash just lying around on the ground," he said. "It's just a basic hygiene problem. If we can keep free-standing food and water away, the coyotes aren't going to come around."

"There are thousands of people on this base," added Henen. "If even a tenth of a percent of people leave pet food and trash

out, it supports the coyotes. This happens a lot out in town, too."

Brent Husung, an NREA natural resources specialist, addressed the coyote situation as precarious, referring to them as what he calls "urban wildlife."

"Coyotes are a great example of urban wildlife," said Brent Husung, an NREA natural resources specialist. "They're a very opportunistic species. Coyotes in our area are not threatened by us anymore, so they take to foraging for food in our trash, eating pet food, and seeking other nourishment not native to their survival."

"One thing people here need to realize is that the base was built on their habitat, so we need to adjust and deal with wildlife in a delicate manner," he added. "One thing we want to encourage here is that residents need to be aware of their actions."

Husung referred specifically to things such as residents controlling their trash as opposed to leaving it out overnight and throwing it away in the morning. Coyotes will smell the trash, wander into the housing areas and pick through the unattended trash bags.

He also mentioned people leaving pet food in their yards. Although it is acceptable for pets to eat outside, if the food is left in the yard, coyotes will eat it. If coyotes and other wildlife are given the opportunity to feed on residents' trash, they will become dependent on it for survival and will continue to roam the housing areas in search of a free meal.

Although coyotes are not considered a threat to humans,

if this problem persists, they could become one, said Husung. Some coyotes and other wildlife carry rabies, which poses a danger to people who come in contact with it.

Husung added several attacks were reported in San Bernardino County last year. All the attacks were carried out by urban wildlife.

To help spread the word and make residents aware of this growing problem, NREA will be issuing a letter to Lincoln Military Housing outlining details on how to decrease the surge of wildlife in the residential areas. More information can be found at <http://www.keepmewild.org>, which will give people tips on how to protect themselves without harming the wildlife.



Heritage Park corridor area that is still being designed and built.

"The park was built to enhance the environment for all the people who live and work on the base," said Lehman. "The park is more about history and promotes interaction with base personnel."

As the ceremony progressed, a description of the base for each decade was read as Marines dressed in period uniforms marched to their designated pillar engraved with a date to show what Marines from that era wore.

As each decade's script was read, Marines and sailors who served, or are serving, aboard the Combat Center were asked to stand to be recognized for their service throughout the years.

"It is wonderful to see how the base has grown exponentially," said M.J. "Mac" Dube, a retired colonel who served aboard the Combat Center as the chief of staff from 1985 through 1989. "I retired 20 years ago, and it amazes me how much the base has gone up since then."

The ceremony closed with Gurganus and Lehman cutting the ribbon, and inviting people to enter the park for the first time.

Heritage Memorial Park consists of 10 pillars that represent each decade of the base. Inscribed on each pillar is a summary of the history of the base during that decade.

Three pillars were left blank to be filled out as the years progress.

Brig. Gen. Charles M. Gurganus, Combat Center commanding general and Bob Lehman, chief engineer and architect with Public Works Division, cut a ribbon to Heritage Memorial Park in an opening ceremony Monday. The memorial park includes 10 pillars that are inscribed with a decade of the base's history and an 18-foot granite center encribed with a map of the base.

"It captures the history of the base, yet leaves room for the future," said Dube, who has made Twentynine Palms his home after retirement. "It provides a historical background of the base, not just for Marines, but visitors as well."

The pillars surround an 18-foot granite center where visitors can view a map of the base in relation to California. The walkway is surrounded by palm trees, and brightly colored flowers on a slightly raised hill to help obscure the road. The park is also offset from the road by 45 degrees to

orient in a northern direction.

At the front of the walkway is a fountain that has a short history of the land during the time of the Native Americans and the gold rush of 1848.

As the Heritage Park corridor area continues to grow, an open park area with artificial grass, fire pits, barbeques and an auditorium will be built; along with a large and small dog park, a roller hockey rink, a skateboard park and a children's water park. All of the new additions are scheduled to be complete by the summer of 2009.
