Private Security Guard





Course Description

This course introduces students to the private security guard profession in the United States. Topics include current trends and the role of private compared to that of police officers. Students explore specialized security fields and career opportunities in various industries. The course also explains computer security, the organizational role for security, risk analysis, litigation, and technological advancements. The course includes crime reporting, regulations on authority to arrest, responding to terrorism and disaster, crime investigations, civil liability and court procedures. Upon successful completion of this course, students may obtain the California Guard Card as well as obtain a baton permit through the Bureau of Security and Investigative Services with the State of California.

Why Private Security Guard?

Security guards and officers patrol and protect property against theft, vandalism, and other illegal activity.

Security guard officers typically do the following:

- Enforce laws and protect an employer's property
- Monitor alarms and closed-circuit TV (CCTV) cameras
- Respond to emergencies
- Control building access for employees and visitors
- Conduct security checks over a specified area
- Write reports on what they observed while
- Detain violators

Guards and officers must remain alert, looking out for anything unusual. In an emergency, they are required to call for assistance from police, fire, or ambulance services. A security guard's responsibilities vary from one employer to another. In retail stores, guards protect people, merchandise, money, and equipment. They may work with undercover store detectives to prevent theft by customers and employees, detain shoplifting suspects until the police arrive, and patrol parking lots.

Security guards, also called security officers, protect property, enforce rules on the property, and deter criminal activity. Some guards are assigned a stationary position from which they monitor alarms or surveillance cameras. Other guards are assigned a patrol area where they conduct security checks.

Career Outlook

Overall employment of security guards and gambling surveillance officers is projected to grow 3 percent from 2019 to 2029, about as fast as the average for all occupations. Security guards will continue to be needed to protect both people and property because of concerns about crime and vandalism. States continue to legalize gambling and casinos continue to grow in number, resulting in the need for gambling surveillance officers and investigators.
